The prolongation of the temporary reintroduction of internal border control Concerning: according to article 25.3 of the Schengen Borders Code.

Dear Commissioner, President, Secretary-General,

Following its earlier communication and in accordance with article 25.3 of Regulation 562/2006, as amended by Regulation 1051/2013 (the Schengen Borders Code), Belgium hereby announces the extension of the temporary internal border controls at the border between the Province of West Flanders and France for the period from 24 March up to and including 12 April 2016.

This decision was prompted by several considerations.

Even though the number of transmigrants dropped significantly in the days following the implementation of the border controls, indicating the dissuasive effect of our measures, the security impact remains high.

Belgium wants to do everything possible to prevent the emergence of tent camps, that have a serious impact on the internal security. In the past few days several attempts to set up tent camps were noticed and almost every day our police services also have to clear the beginnings of tent camps.

While transiting, many migrants try to get into the Zeebrugge port area which results in well-known security and safety risks. Apart from the hazards to the physical integrity and wellbeing of the

migrants, there is also a lot of material damage. In addition, this has an impact on the general feeling of insecurity of the inhabitants of the region.

The border controls of the past month have definitely led to an increased level of security in the border region and have had an impact on organised immigration crime, since special attention was also given to human smuggling.

With improved weather conditions ahead, the chances are that more people will want to attempt to cross over to the UK. The presence of large concentrations of migrants in the immediate vicinity of our border and a motorway leading to our country offer a lot of possibilities to get to Belgium quickly.

Moreover, it has been noticed that travel routes are increasingly diversifying and that the marina of Nieuwpoort is also used by smugglers as point of departure.

If the circumstances remain unchanged, Belgium will extend the border controls, in accordance with article 23 and article 24 of the Schengen Borders Code.
