Whereas:

- (1) The terms of office of 14 Judges and six Advocates-General of the Court of Justice will expire on 6 October 2021.
- Appointments to these posts should therefore be made for the term of office starting on 7 October 2021 and expiring on 6 October 2027.
- (3) It has been proposed that the term of office of Mr Eugene REGAN as Judge of the Court of Justice be renewed.
- (4) It has been proposed that the term of office of Mr Athanasios RANTOS as Advocate-General of the Court of Justice be renewed.
- (5) Mr Dimitrios GRATSIAS has been nominated for a first term of office as Judge of the Court of Justice.

- (6) Mr Nicholas EMILIOU has been nominated for a first term of office as Advocate-General of the Court of Justice.
- (7) The panel set up under Article 255 of the Treaty on the Functioning of the European Union has given a favourable opinion on the suitability of those candidates to perform the duties of Judge or Advocate-General of the Court of Justice,

HAVE ADOPTED THIS DECISION:

Article 1

The following are hereby appointed Judges of the Court of Justice for the period from 7 October 2021 to 6 October 2027:

- Mr Eugene REGAN,
- Mr Dimitrios GRATSIAS.

Article 2

The following are hereby appointed Advocates-General of the Court of Justice for the period from 7 October 2021 to 6 October 2027:

- Mr Athanasios RANTOS,
- Mr Nicholas EMILIOU.
