STATEMENT BY GERMANY

"Germany is of the opinion that maritime borders within the meaning of Article 2(1) of the draft Regulation (*This Regulation applies to cross-border obstacles in land or maritime border regions of neighbouring Member States*') concern only the German maritime borders with the Kingdom of the Netherlands, the Kingdom of Denmark and the Republic of Poland."

STATEMENT BY THE COMMISSION

"The Commission draws attention to the fact that the co-legislators' amendment to its amended proposal which removes the obligation to set up national public registers on cross-border files and maintains a single register at EU level has budgetary and human resources implications for the Commission.
