Subject:	Council position on draft amending budget No 1 to the general budget for 2024: Amendments of the 2024 budget required due to the MFF revision

---

1. On 29 February 2024, the Commission submitted to the Council draft amending budget (DAB) No 1 to the general budget for 2024<sup>1</sup> introducing the necessary changes to the budget 2024 stemming from the revision of the Multiannual Financial Framework (MFF).

The amended MFF Regulation<sup>2</sup> applies retroactively as of 1 January 2024 and includes *inter alia* amendments to the MFF ceilings that have been communicated in the updated technical adjustment of the MFF for 2024 in the form of a Commission Communication adopted on 29 February 2024<sup>3</sup>, as foreseen in Article 4(1) of the MFF Regulation.

In order to reflect the impact of the MFF revision on the financial year 2024, DAB No 1/2024 covers the following elements:

- creation of the budget nomenclature and remarks to cater for the Ukraine Facility<sup>4</sup>, and mobilisation of the new special instrument, the Ukrainian Reserve, with an amount of EUR 4.8 billion of commitment appropriations (c/a) and EUR 3.8 billion of payment appropriations (p/a) for the Union's support other than in the form of loans, including administrative support. in line with the MFF Regulation;
- reinforcement of the European Defence Fund within the framework of the Strategic Technologies for Europe Platform (STEP)<sup>5</sup> by EUR 376 million in c/a;
- adjustment to the budget nomenclature in order to split the Solidarity and Emergency Aid Reserve in two separate instruments and to increase the amounts for each instrument;
- creation of the budget nomenclature and remarks to cater for the Reform and Growth Facility for the Western Balkans, with an amount of EUR 501 million in c/a in reserve and EUR 23.9 million in p/a in reserve, pending the adoption of the legal basis;
- reduction of the level of c/a in the reserve for the European Globalisation Adjustment Fund for Displaced Workers (EGF) by EUR 175.7 million in 2024.

Additionally, DAB No 1/2024 includes an adjustment to the budget remarks of the budget line for support expenditure of the Digital Europe Programme following the political agreement reached in December 2023 by the European Parliament and the Council on the establishment of the Artificial Intelligence Office.

Overall, the net impact of DAB No 1/2024 on expenditure amounts to an increase of EUR 5 833.7 million in c/a and an increase of EUR 4 143.6 million in p/a.

2. In order to allow the Council to adopt a position on this draft amending budget without delay, the Council has to decide, considering the urgency of the matter, to shorten, in accordance with Article 3(3) of its Rules of Procedure, the eight-week period laid down in Article 4 of Protocol No 1 on the role of national Parliaments in the European Union.
3. The Budget Committee examined DAB No 1/2024 at its meetings on 1 and 8 March 2024, and was able to accept it without any changes.
4. At the close of its examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to:
  - adopt the Council’s position on DAB No 1/2024 as set out in point 3;
  - instruct the Presidency to prepare the budgetary documents to be sent to the European Parliament and to approve the draft letter in the annex to that effect; and
  - have the Council Decision adopting the Council’s position on draft amending budget No 1 of the European Union for the financial year 2024, as set out in document 7382/24, published in the *Official Journal of the European Union*;
  - in view of the urgency of the matter, decide to derogate, on the basis of Article 3(3), second subparagraph, of the Council’s Rules of Procedure, from the eight-week period referred to in the first subparagraph of that article.
