I. <u>INTRODUCTION</u>

- 1. On 16 October 2023, the <u>Commission</u> put forward a proposal for a Regulation on preventing plastic pellet losses to reduce microplastic pollution¹. This proposal sets requirements for the handling of plastic pellets by economic operators and EU and non-EU carriers at all stages of the supply chain. Losses of plastic pellets, one of the main sources of unintentional microplastic pollution, often result from a lack of awareness or poor handling practices and can be abated by swift measures. However, once lost in the environment, plastic pellets are nearly impossible to retrieve as they disperse easily over large distances by wind and water.
- 2. The <u>Economic and Social Committee</u> adopted its opinion on the proposal on 14 February 2024. The <u>Committee of the Regions</u> adopted its opinion on the proposal on 18 April 2024.
- 3. The <u>European Parliament</u> adopted its position at first reading on 23 April 2024² in the previous legislative term under the rapporteurship of João Albuquerque (S&D). In the new legislative term of the EP, César Luena (S&D) has been appointed Rapporteur.

II. WORK IN THE COUNCIL

- 4. Within the <u>Council</u>, the Working Party on the Environment (WPE) examined the proposal at technical level, following a presentation of the proposal and the accompanying impact assessment by the Commission on 14 February 2024.
- 5. On 25 March 2024, the <u>Council</u> (Environment) held a policy debate on adequacy of the proposed measures, on responsibility of different actors and on maritime transport³. Following seven WPE meetings and political guidance obtained from Coreper on 6 November 2024, the Environment Council reached a General Approach on the Plastic pellets proposal on 17 December 2024⁴.

- 6. The interinstitutional negotiations started on 29 January 2025. In a total of 15 technical meetings, the negotiations allowed for substantial progress, finding common ground on a number of issues.
- 7. With a view to the second and possibly final political trilogue scheduled for 8 April 2025, the Presidency seeks a revised mandate. The four-column document in the <u>Annex</u> to this note presents provisionally agreed rows in green, open issues for political discussion in red, and provisions which will be aligned depending on the outcome of the political discussions in yellow.

III. STATE OF PLAY OF NEGOTIATIONS

- 8. Having engaged in constructive technical negotiations with the European Parliament on the basis of the General Approach, the Presidency tables a compromise package containing the outcome of technical discussions as well as Presidency suggestions with a view to the second political trilogue. The compromise package, laid out in the four-column document, is guided by the positions shared by delegations in two WPE meetings on 13 January and 25 March 2025, as well as through the exchanges with the European Parliament.
- 9. With respect to the provisions where a common ground between the Presidency and the European Parliament was identified, the Presidency would like to particularly highlight the following:
 - Definitions of 'plastic pellet', 'spill' and 'loss' [rows 63-65] were adjusted and new maritime-related definitions of 'shipper', 'operator', and 'agent' [rows 69a-c] were added in Art. 2 as per the Council General Approach.
 - Maritime transport was kept in the scope of the Regulation in Article 4a [rows 108b-h]
 as per the Council General Approach.

- Public access to information in Art. 7a [rows 132a-k] was included mostly as per the General Approach. Similarly, verification of compliance and reporting in Art. 8 [rows 133-139a] as well as the provisions concerning non-compliance in Art. 10 [rows 146-151] were provisionally agreed close to the Council position, with several issues pending outcome on open political provisions.
- Complaint-handling, access to justice, penalties and compensations in Art. 14, 15, and
 16 [rows 174-194] were provisionally agreed close to the Council position.
- Delegated powers in Art. 17, 18, and 18a [rows 195-201b].
- Traceability in Art. 17b [rows 201e-201i], where the Parliament agreed to replace their amendments with an introduction of a new point (fa) in Article 18b(1) [row 208m] on evaluation and review.
- Evaluation and review in Art. 18b [rows 208e-208u] has been provisionally agreed as
 per the structure laid down in the Council General Approach and largely with the same
 aspects as included in the Council position.

IV. OUTSTANDING ISSUES

10. Several issues remain open on which the co-legislators did not find a compromise solution at the technical level. Therefore, the Presidency puts forward the following issues for consideration by delegations in view of obtaining a revised mandate for the second political trilogue.

11. The open issues include:

i. Zero plastic pellet loss in Art. 1 [row 57]: the Presidency suggests including this reference in a form of an aspirational goal in a relevant recital [row 23], with a language which ensures this is not a binding provision.

- ii. <u>Information to be provided</u> in Art. 3(3a), Art. 18b(ka), Annex IVb and recital 13a [rows 80a, 208s, 23a and 265at]: the Parliament proposed this package to replace their amendments on labelling [rows 25, 229, 236, 251, 252]. The Presidency believes this package can bring added environmental benefits without imposing excessive burden, as it complements already existing obligations on certain suppliers of plastic pellets to provide information as set out in Annex XVII to the REACH Regulation.
- Authorised representative in Art. 3a [rows 81a-d]: both the Parliament and the Council share the goal of providing for a level playing field between EU- and non-EU carriers. Considering the options available (i.e. the Commission proposal, including a proposal to delete some obligations for the EU carriers; the Parliament mandate; the Council General Approach), the Presidency believes that keeping the authorised representative in the Regulation is the most appropriate way to provide for level playing field.
- iv. Obligations of economic operators, notably the <u>obligations of small enterprises</u>, have been one of the most important issues given the need to strike a balance between simplified administrative obligations and the additional environmental benefits:
 - Certification of small enterprises in Art. 4(2a) [rows 88, 88a and 111a]: the Parliament is insisting on one-time certification obligation for the small enterprises above 1000 tonnes which would be valid for five years [row 111a]. After the first certification, small enterprises would have a choice of either renewing the certificate [row 88a] or notifying the updated risk management plan and the self-declaration of conformity every five years [row 88]. The Presidency believes that such a solution could still assure an adequate level of environmental protection, while providing small companies with lighter administrative burden and further decreasing the costs of compliance. In addition, small enterprises could still opt for the certification process, if they wish so.

- Internal assessment of small enterprises in Art. 4(9) [row 105]: the Parliament is also insisting to remove small companies above 1000 tonnes from the obligation to carry out an annual internal assessment on the compliance with risk management plan or with the permit conditions [row 105]. The Presidency shares the view that the procedure of internal assessment is more suitable for larger enterprises where management is more removed from handling process, and suggests to alleviate this burden on small enterprises without compromising on the effectiveness of the Regulation.
- Support and assistance relating to compliance with the Regulation in Art. 12(2) [rows 164-169]: in technical discussions, the Presidency insisted that all actors in the supply chain should have access to support and assistance. The Parliament provisionally indicated openness to the Council's less restrictive approach to the assistance regarding compliance.
- Annex I elements relevant to small enterprises (additional measures and possible exemptions for small and micro-enterprises): the Parliament provisionally agreed to withdraw small enterprises from certain obligations in Annex I [rows 237-240] as per the Council General Approach. However, the Parliament may insist on a general exemption for all economic operators regarding equipment and measures in Annex I, whenever such exemption can be justified [row 231a and 236a]. In addition, the Parliament has maintained the request that micro-enterprises do not have an obligation to put in place certain measures in Annex I but only consider them [rows 231b and 236b].

In addition, the Parliament has reserved its position with regard to the level of the threshold for additional obligations under this Regulation (1000 tonnes), as well as on the entirety of Annex I.

- v. The Presidency believes that lighter regime reducing the burden on the smaller enterprises while keeping environmental integrity of the Regulation is the key to ensure support of all institutions involved. The Presidency will pursue an outcome from the negotiations that reflects the core rationale of the Council general approach. Compliance through permits in Art. 5a [rows 121a-g] and exemptions for operators registered in EMAS and EMS from obligations under the Regulation [rows 123-123d] for which the Presidency suggests to keep the solutions from the General Approach.
- vi. <u>Incidents and accidents</u> in Art. 9 [rows 140-145]: with the aim of ensuring that incidental or accidental plastic pellet losses are properly reported, the Parliament requests to specify the information to be provided by all relevant actors to competent authorities in case of incidents or accidents. This comes in addition to the requirement to minimise the health and environmental consequences and to prevent any further incidents or accidents. The Presidency suggests to support this approach, which reduces burden in comparison with the original requested of the Parliament to use a form in Annex IVa [rows 265a-as] to track all losses of plastic pellets.
- vii. <u>Date of application</u> in Art. 19 [rows 211 and 211a] represent a sensitive issue in the negotiations and the Presidency is well aware of the balance in the compromise taken in the General Approach. Therefore, the Presidency proposes that:
 - The date of application of the Regulation should allow for adequate implementation by Member States. The Presidency suggests to remain as close as possible to the Council position, which is 24 months.
 - The date of application of the maritime-related obligations must reflect the specificity of that sector. The Presidency suggests to maintain the Council General Approach of 36 months, but in any event provide for more time for the maritime sector as compared to other provisions of this Regulation.

V. <u>CONCLUSION</u>

12. With a view to preparing a revised mandate for the trilogue on 8 April 2025, the <u>Permanent Representatives Committee</u> is invited to examine the Presidency's compromise suggestions on the Regulation on preventing plastic pellet losses to reduce microplastic pollution.

13. Delegations are invited to indicate whether they can back the proposed package in view of the trilogue, and may raise any item in the package that they cannot accept.

	approach is essential for ensuring the commitment of all economic actors involved in plastic pellet handling towards loss prevention. Since 2015, the European plastic manufacturing industry has progressively adopted the international Operation Clean Sweep® programme (OCS) as a voluntary pledge. Under this programme, each company making or handling pellets recognises the importance of making zero pellet losses and commits to adopting best practices. While such practices are generally well understood by OCS signatories, they have not been comprehensively implemented.
