Dear Colleagues,

By letters of 27 January, 5 February, 26 February and 17 March 2021, I informed you about the temporary reintroduction of targeted border controls at all internal Belgian borders, and this in accordance with the Schengen Borders Code, in order to prevent the spread of the COVID-19 virus.

These controls at internal borders were reintroduced to enforce the decision taken on 22 January by the Belgian Government concerning non-essential travel to and from Belgium from 27 January. In the meantime the Government confirmed its intention to maintain this restriction on non-essential travel until 18 April.

Taking account of the current deteriorating epidemiological situation in Belgium as well as in other parts of the EU, and in particular the increased risk of the spread of the more contagious variants of the COVID-19 virus, targeted checks remain essential to ensure that these travel restrictions are respected. For this reason and in line with articles 25 and 27 of the Schengen Borders Code, I have to inform you that, for a further period from 2 April until 18 April, some of these checks will be carried out at the internal borders.

As in my previous letters, I would like to reiterate that no internal borders will be closed and that all checks will be carried out in a proportionate and non-discriminatory way, while ensuring the smooth border crossing for essential travel, the supply chain and the local cross-border traffic.
