**'I/A' ITEM NOTE**

Subject:	Council Decision appointing six members and six alternate members, proposed by the Hellenic Republic, of the Committee of the Regions - Adoption

---

1. By letter of 12 January 2024<sup>1</sup>, the Secretary-General of the Committee of the Regions notified the Council of the end of the mandates on the basis of which Mr Konstantinos AGORASTOS, Mr Konstantinos BAKOYANNIS, Mr Dimitrios KARNAVOS, Mr Ioannis KOURAKIS, Ms Rodi KRATSA, and Mr Georgios PATOULIS, members of the Committee of the Regions, were proposed for appointment and appointed, and of the end of the mandates on the basis of which Mr Nikolaos CHIOTAKIS, Ms Katerina CHRYSSOPOULOU, Mr Dimitrios KALOGEROPOULOS, Mr Georgios KASAPIDIS, Mr Dimitrios PETROVITS, and Mr Nikolaos VAFEIADIS, alternate members of the Committee of the Regions, were proposed for appointment and appointed.
2. Under Article 305 TFEU, the Council appoints members and alternate members of the Committee of the Regions, acting by a qualified majority on proposals by the respective Member States.

3. In accordance with that provision and for the purpose of the replacement of Mr Ioannis KOURAKIS and Mr Georgios PATOULIS, the Greek Government has proposed<sup>2</sup> Mr Nikolaos CHARDALIAS, *περιφερειάρχης Αττικής* (Governor, Attica Region), and Mr Ioannis MYLONAKIS, *δήμαρχος, Δήμος Αγίας Παρασκευής* (Mayor, Municipality of Agia Paraskevi), representatives of local or regional bodies who hold a local or regional authority electoral mandate, as members of the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2025.
4. For the purpose of filling the posts left vacant by Mr Konstantinos AGORASTOS, Mr Konstantinos BAKOYANNIS, Mr Dimitrios KARNAVOS, and Ms Rodi KRATSA, the Greek Government has proposed<sup>3</sup> to reappoint, on the basis of different national mandates, Mr Konstantinos AGORASTOS, *περιφερειακός σύμβουλος Θεσσαλίας* (Regional Councillor, Thessaly Region), Mr Konstantinos BAKOYANNIS, *δημοτικός σύμβουλος, Δήμος Αθηναίων* (Municipal Councillor, Municipality of Athens), Mr Dimitrios KARNAVOS, *δημοτικός σύμβουλος, Δήμος Καλλιθέας* (Municipal Councillor, Municipality of Kallithea), and Ms Rodi KRATSA, *περιφερειακή σύμβουλος Ιονίων Νήσων* (Regional Councillor, Ionian Islands Region), representatives of local or regional bodies who hold a local or regional authority electoral mandate, as members of the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2025.

5. For the purpose of the replacement of Ms Katerina CHRYSSOPOULOU, Mr Dimitrios KALOGEROPOULOS, and Mr Nikolaos VAFEIADIS, the Greek Government has proposed<sup>4</sup> Ms Meropi-Spiridoula IDRAIOU, *δημοτική σύμβουλος, Δήμος Κεντρικής Κερκύρας και Διαποντίων Νήσων* (Municipal Councillor, Municipality of Central Corfu and Diapontia Islands), Mr Ioannis IOANNIDIS, *δημοτικός σύμβουλος, Δήμος Αμαρουσίου* (Municipal Councillor, Municipality of Amaroussion), Mr Nikolaos KARAPANOS, *δημοτικός σύμβουλος, Δήμος Ιεράς Πόλεως Μεσολογγίου* (Municipal Councillor, Municipality of the Holy City of Messologhi), representatives of local bodies who hold a local authority electoral mandate, as alternate members of the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2025.
6. For the purpose of filling the posts left vacant by Mr Nikolaos CHIOTAKIS, Mr Georgios KASAPIDIS, and Mr Dimitrios PETROVITS, the Greek Government has proposed<sup>5</sup> to reappoint, on the basis of different national mandates, Mr Nikolaos CHIOTAKIS, *περιφερειακός σύμβουλος Αττικής* (Regional Councillor, Attica Region), Mr Georgios KASAPIDIS, *περιφερειακός σύμβουλος Δυτικής Μακεδονίας* (Regional Councillor, Western Macedonia Region), and Mr Dimitrios PETROVITS, *δημοτικός σύμβουλος, Δήμος Αλεξανδρούπολης* (Municipal Councillor, Municipality of Alexandroupolis), representatives of local or regional bodies who hold a local or regional authority electoral mandate, as alternate members of the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2025.
7. In view of the above, the Permanent Representatives Committee is therefore invited to confirm its agreement on the text of the Decision set out in document 7591/24 and to suggest that the Council adopt that Decision as an 'A' item at a forthcoming meeting.
