Subject:	Transfer of appropriations No DEC 07/2022 within Section III - Commission - of the general budget for 2022

1. On 23 March 2022, the Commission submitted to the Council proposal for transfer of appropriations No DEC 07/2022, in accordance with Article 31(1) of the Financial Regulation¹.

The purpose of this proposal is to transfer a total amount of EUR 350 million in non-differentiated appropriations from item 08 02 05 11 (*Reserve for crises in the agricultural sector*) to item 08 02 03 11 (*Exceptional measures*), as set out in 7514/22.

2. The aim of the transfer is to finance part of the package of exceptional measures for the farmers most affected by market disturbances caused by the crisis in Ukraine, in accordance with point 22 of Interinstitutional Agreement 2013/C 373/01 of 2 December 2013.
 3. The Budget Committee examined the proposal for a transfer at its meeting on 31 March 2022.
 4. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations, as set out in 7514/22; and
 - the draft letter in the ANNEX to this note.
