THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on European Union, and in particular Article 29 thereof,

Having regard to Council Regulation (EU) 2023/427 of 25 February 2023 amending Regulation (EU) No 833/2014 concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine<sup>1</sup>, and in particular Article 1, point (20), thereof,

Having regard to the proposal from the High Representative of the Union for Foreign Affairs and Security Policy,

Whereas:

- (1) On 25 February 2023, the Council adopted Regulation (EU) 2023/427, which amended Council Regulation (EU) No 833/2014<sup>1</sup> and introduced further restrictive measures to suspend the broadcasting activities in the Union, or directed at the Union, of certain media outlets. Those outlets are set out in Annex V to Regulation (EU) 2023/427. Pursuant to Article 1, point (20), of Regulation (EU) 2023/427, the applicability of such measures in respect of one or several of those media outlets is subject to the adoption of implementing acts by the Council.
- (2) Having examined the respective cases, the Council has concluded that the restrictive measures referred to in Article 2f of Regulation (EU) No 833/2014 should apply from 10 April 2023 in respect of the entities set out in Annex V to Regulation (EU) 2023/427,

HAS ADOPTED THIS REGULATION:

*Article 1*

The measures referred to in Article 2f of Regulation (EU) No 833/2014 shall apply from 10 April 2023 in respect of the entities set out in Annex V to Regulation (EU) 2023/427.

*Article 2*

This Regulation shall enter into force on the day following that of its publication in the *Official Journal of the European Union*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
