**3. Informal videoconference of the Ministers of Agriculture  
and Fisheries on 13 May 2020: 7619/20**  
*Preparation*

The SCA took note of the information provided by the Presidency on the organisation of, and subjects to be discussed at, the second Ministerial Videoconference on 13 May and of delegations' comments and questions. It agreed to invite a representative of Copa-Cogeca to make a statement at the beginning of the meeting.

The SCA also took note of the latest information provided by the Commission on the measures taken and planned under the CAP to respond to the COVID-19 pandemic

The SCA took note of the presentation made by the Commission of the second package of Delegated Regulations introducing exceptional measures to support the agri-food sector in order to minimise the consequences of the COVID-19 pandemic, and of delegations comments who broadly welcomed the package but considered that further measures were necessary.

In this context, the SCA also took note:

- of the objection expressed by one delegation (BG) concerning the Commission Regulation included in document 7690/20, while noting the absence of the reinforced qualified majority for the Council to oppose the two delegated acts under the urgency procedure (docs 7690/20 and 7688/20 + ADD 1), which has to be confirmed by means of the ongoing silence consultation procedure expiring on 19 May;
- that, for the delegated act adopted under the standard procedure (7737/20), no delegation voiced its intention to raise an objection. The President concluded that the item would be forwarded to Coreper for approval, by written procedure, of a letter to be sent on the intention not to raise objections;

- of the request made by one delegation (LT) to include a statement in the summary record.<sup>1</sup>

**5. Amending Regulation regarding exceptional EAFRD support in response to the COVID-19 outbreak**

*Presentation by the Commission*

The SCA took note of the Commission presentation on the proposal amending the current Rural Development Regulation with regard to exceptional EAFRD support in response to the COVID-19 outbreak, as well as of delegations' reactions and comments.

The SCA also took note of the Commission's clarification that, in Article 1 of the proposal, the square brackets around the deadline for the lump-sum payment (31/12/2020) was a typo, which needed to be corrected in the final version of the legal text.

**(a) Lithuania's statement on COMMISSION DELEGATED REGULATION (EU) 2020/591 of 30.4.2020 opening a temporary exceptional private storage aid scheme for certain cheeses and fixing the amount of aid in advance (doc. 7688/20 + ADD 1)**

Lithuania neither intends to object the adoption of the Delegated Regulation on a temporary exceptional private storage aid scheme for certain cheeses, nor questions its urgent entering into the force, but regrets that certain factors were not taken into account when considering the adoption of this measure.

Firstly, quota distribution with “only per production” key, without taking into account export proportions and its dependency is not acceptable to Lithuania. The quota allocated is not sufficient thereto.

Moreover, support rates are regrettably unchanged from the last deployment of this *safety net* measure back in 2014 – 2016. Lithuania believes that a regular inflation coefficient had to be applied here.

Finally and the most importantly, Lithuania notes and regrets that redistribution mechanism was not offered for the quantities (poss.) not claimed by Member States.

**Therefore, Lithuania urges the Commission to carefully monitor and assess the uptake of the scheme with a review of the state of play in early June and come up with the proposals for the redistribution of quantities unclaimed, as well as additional quantities.**
