**amending Decision 2014/145/CFSP concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine**

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on European Union, and in particular Article 29 thereof,

Having regard to the proposal from the High Representative of the Union for Foreign Affairs and Security Policy,

Whereas:

- (1) On 17 March 2014, the Council adopted Decision 2014/145/CFSP <sup>(1)</sup>.
- (2) The Union remains unwavering in its support for Ukraine's sovereignty and territorial integrity.
- (3) On 24 February 2022, the President of the Russian Federation announced a military operation in Ukraine and Russian armed forces began an attack on Ukraine. That attack is a blatant violation of the territorial integrity, sovereignty and independence of Ukraine.
- (4) In view of the gravity of the situation, the Council considers that it is appropriate to add businesspersons supporting or benefiting from the Russian Government and natural persons associated with them, including family members unduly benefiting from them.
- (5) The Council also considers that the so-called Ministers and the members of the 'People's Council' of the so-called 'Donetsk People's Republic' and 'Luhansk People's Republic' should be added to the list.
- (6) Furthermore, the Council considers that companies financially supporting and benefitting from the Government of the Russian Federation and supporting materially or financially actions which undermined or threatened the territorial integrity, sovereignty and independence of Ukraine should also be added to the list.
- (7) As a result, 217 individuals and 18 entities should be added to the list of persons, entities and bodies subject to restrictive measures set out in the Annex to Decision

- (8) The Council considers that a derogation mechanism for diplomatic missions to the assets freeze and the prohibition from making funds and economic resources available to designated persons and entities should be introduced.
- (9) The Council considers that a derogation mechanism for certain operations applicable to certain entities listed in the Annex to Decision 2014/145/CFSP should be added.
- (10) Decision 2014/145/CFSP should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

*Article 1*

Decision 2014/145/CFSP is amended as follows:

- (1) In Article 2, paragraph 4, the following point e) is added as follows:  
‘e) to be paid into or from an account of a diplomatic mission or consular post or an international organization enjoying immunities in accordance with international law, insofar as such payments are intended to be used for official purposes of the diplomatic mission or consular post or international organization.’
- (2) In Article 2, the following paragraphs are added:  
‘9. By way of derogation from Article 2, the competent authorities of a Member State may authorise the release of certain frozen funds or economic resources belonging to the entities listed under entry numbers 79, 80, 81 and 82 in the Annex, or the making available of certain funds or economic resources to these entities, under such conditions as the competent authorities deem appropriate and after having determined that such funds or economic resources are necessary for the termination by XX YY 2022 [*6 months after adoption of this decision*] of operations, contracts, or other agreements, including correspondent banking relations, concluded with these entities before [*date of adoption of this decision*].  
  
10. By way of derogation from Article 2, the competent authorities of the Member States

may, under such conditions as they deem appropriate, authorise the release of certain frozen funds or economic resources, or the making available of certain funds or economic resources to a natural or legal person, entity or body listed in Annex I, after having determined that:

- (a) the funds or economic resources are necessary for the sale and transfer by (six months after adoption date) of proprietary rights in a legal person, entity or body established in the Union where these proprietary rights are directly or indirectly owned by a natural or legal person, entity or body listed in Annex I; and
  - (b) the proceeds of such sale and transfer remain frozen.’
- (3) The persons and entities listed in the Annex to this Decision shall be added to the list set out in the Annex to Decision 2014/145/CFSP.

*Article 2*

This Decision shall enter into force on the day of its publication in the *Official Journal of the European Union*.
