On page 23, in Article 22(d) ‘ICT-related incident management policy’, first subparagraph:

for: ‘(d) retain all evidence relating to ICT-related incidents for a period that shall be no longer than necessary for the purposes for which the data are collected, commensurate with the criticality of the affected business functions, supporting processes, and ICT and information assets, in accordance with Article 15 of Commission Delegated Regulation (EU) 2024/1772 ⁽¹²⁾ and with any applicable retention requirement pursuant to Union law;’

read: ‘(d) retain all evidence relating to ICT-related incidents for a period that shall be no longer than necessary for the purposes for which the data are collected, commensurate with the criticality of the affected business functions, supporting processes, and ICT and information assets, in accordance with Article 8(2) of Commission Delegated Regulation (EU) 2024/1772 ⁽¹²⁾ and with any applicable retention requirement pursuant to Union law;’.
