Statement by Austria

"Austria assumes that Article 5(4) of the Regulation on harmonised indices of consumer prices implies the following for Member States: In accordance with the subsidiarity principle, under Article 5(4) Member States may lay down an appropriate provision concerning aspects of the data collection method, e.g. specifying the required level of detail, the level of aggregation and the frequency of data transfer. With regard to the aim of avoiding the imposition on undertakings of any additional burden in connection with this new form of data collection under Article 5(4) (recital 20 - according to COM's explanatory memorandum to the proposal, no impact assessment is required!), it is to be assumed that it will be sufficient for statistical units (enterprises), if requested by the national bodies (as in existing data collection), to send the latter the relevant aggregated data, if available in electronic form, once a month and that Member States may exempt SMEs from the reporting obligation in accordance with the European initiatives (e.g. Better Regulation, Small Business Act)."

"The Commission underlines the need to strive for effectiveness, efficiency and "value for money" in the external action of the EU and to find innovative solutions generating efficiency gains and drawing synergies. The Commission and the HR will set up a Mission Support Platform (MSP), made up of two cells in the Commission and the EEAS aiming at increasing the efficiency of the management and the support of the Common Security and Defence Policy (CSDP) civilian Missions in their key aspects of the enabling functions (Human Resources; Logistic, including support from the central Warehouse; Procurement and Framework Contracts; Finance; IT and Communication and Information Systems (CIS); Document Management/Archiving; Legal Advice; Medical support.). The concept stems from lessons learned of almost ten-years of experience of CSDP civilian Missions, notably on their needs in terms of mission support, and on how to benefit from the opportunities offered by the post Lisbon institutional framework, which gives greater resources and coherence to the CSDP. Statement by Ireland

"Ireland wishes to record its view that the proposal for a Regulation of the European Parliament and of the Council amending Regulation (EC) No 1683/1995 of 29 May 1995 laying down a uniform format for visas does not constitute a development of the provisions of the Schengen acquis for Ireland. It is a measure pursuant to Title V of Part Three of the Treaty on the Functioning of the European Union and is therefore subject to Protocol (No. 21) to the Treaties on the position of the United Kingdom and Ireland in Respect of the Area of Freedom, Security and Justice. Ireland notes that Regulation (EC) No 1683/1995 of 29 May 1995 was adopted before the Schengen acquis was incorporated into EU law by the Treaty of Amsterdam and was not defined as part of the Schengen acquis in Council Decision 1999/435/EC concerning the definition of the Schengen acquis for the purpose of determining, in conformity with the relevant provisions of the Treaty establishing the European Community and the Treaty on European Union, the legal basis for each of the provisions or decisions which constitute the acquis. Furthermore Ireland notes the precedents set by previous amendments to Regulation (EC) No 1683/1995, namely Regulation (EC) No 334/2002 and Regulation (EC) No 856/2008, which are both subject to the Protocol on the position of the United Kingdom and Ireland annexed to the Treaty on European Union and to the Treaty establishing the European Community. Ireland exercised its right to opt in under Regulation (EC) No 334/2002.

Accordingly, Ireland does not consider that it should be automatically excluded from the proposal for a Regulation of the European Parliament and of the Council amending Regulation (EC) No 1683/1995 of 29 May 1995 laying down a uniform format for visas as set out in Recital (5). Ireland remains firmly of the opinion that it is legally correct that Ireland should be entitled to exercise its right to opt into this proposal."

Statement by the United Kingdom

"The United Kingdom wishes to record its view that the proposal for a Regulation of the European Parliament and of the Council amending Regulation (EC) No 1683/1995 of 29 May 1995 laying down a uniform format for visas does not constitute a development of the provisions of the Schengen acquis in which the United Kingdom does not take part, and therefore being a measure proposed pursuant to Title V of Part Three of the Treaty on the Functioning of the European Union, is subject to Protocol (No. 21) to the Treaties on the position of the United Kingdom and Ireland in Respect of the Area of Freedom, Security and Justice. The United Kingdom notes that Regulation (EC) No 1683/1995 of 29 May 1995 was not adopted as a development of the provisions of the Schengen acquis in which the United Kingdom does not take part, and notes the precedents set by Regulation (EC) No 334/2002 and Regulation (EC) No 856/2008 which amend Regulation (EC) No 1683/1995, and which are both subject to Protocol (No. 21) to the Treaties.

Accordingly, the United Kingdom does not consider that it is automatically excluded from the proposal for a Regulation of the European Parliament and of the Council amending Regulation (EC) No 1683/1995 of 29 May 1995 laying down a uniform format for visas as set out in Recital (5). Instead, the United Kingdom has decided not to exercise its right under Protocol 21 to opt in to the proposal for a Regulation of the European Parliament and of the Council amending Regulation (EC) No 1683/1995 of 29 May 1995 laying down a uniform format for visas."
