- (g) the width of the horizontal spray boom, if applicable;

Art. 33.2. (m) the applicable EU market ISO requirements on dead (rest) volumes and any relevant environmental standards for newly sold application equipment in professional use.

Newly sold application equipment for professional use should hold the EU market ISO requirements on dead (rest) volumes. Relevant CEN approved technical parameters related to PPP application equipment should be duly documented and transferred to the buyer. It is required to be issued by the producer or his representative and entered by the purchaser in the electronic register of application equipment in professional use referred to in Article 33. A similar obligation to enter the EU market ISO requirement in the electronic register applies in case of a transfer of ownership of any other changes of ownership of application equipment in professional use that holds the EU market ISO requirement.
