21. **Proposal for a Regulation of the European Parliament and of the Council amending Regulation (EU) No 525/2013 as regards the technical implementation of the Kyoto Protocol to the United Nations Framework Convention on Climate Change (First reading) (Legislative deliberation)**
- **Presidency debriefing on the outcome of the informal trilogue**

The Committee was informed by the Presidency on the outcome of the third informal trilogue on 17 March 2014 where an agreement ad referendum was reached with the European Parliament. The Committee approved the overall compromise text set out in the Annex to document 7850/14 and authorised the Presidency to send a letter to the European Parliament confirming agreement by the Committee of the draft compromise package. UK maintained a parliamentary scrutiny reserve. The Committee took note of the intention of the Commission to table a statement on the procedure of adoption of implementing acts, and of PL to table a statement with regard to recital 5c, to the minutes of the Council at the time of adoption. Some delegations called for a Council statement on the horizontal issue of delegated acts to be included in the minutes of the relevant Council meeting.

The Committee approved, by qualified majority, the final compromise text (doc. 7252/1/14 REV 1) and agreed that the letter confirming its agreement on the text be sent to the European Parliament with a view to reaching an agreement at first reading.

The Commission announced that it will enter a statement on the procedure of adoption of implementing acts to the minutes of the relevant Council meeting.

The Committee

- endorsed the final compromise text as set out in Annex to document 7357/14 amended with the compromise text sent by e-mail to delegations by the Presidency on 18 March 2014;
- mandated the Presidency to inform the European Parliament that, should the European Parliament adopt its position at first reading, in accordance with Article 294 paragraph 3 of the Treaty, in the form set out in the compromise package contained in the Annex to document 7357/14 (subject to revision by the legal linguists of both institutions) amended with the compromise sent by e-mail by the Presidency on 18 March 2014, the Council would, in accordance with Article 294, paragraph 4 of the Treaty, approve the European Parliament's position and the act should be adopted in the wording which corresponds to the European Parliament's position.

The Presidency debriefed the Committee on the outcome of the third informal trilogue that could reach full political agreement, in particular on Article 6 of the proposal. The Presidency will present the text to the Committee on 26 March 2014 with a view to reaching a first reading agreement.
