Statement by the Commission

"Article 13(1) of Regulation (EU) 2017/352 requires Member States to ensure that a port infrastructure charge is levied. Member States have taken measures to implement this obligation. It is therefore the responsibility of each Member State to bring its national law in conformity with the new transitional provisions of Regulation (EU) 2017/35, as well as to ensure legal certainty within the national legal order.

In so far as, in the context of Article 21(3) of Regulation (EU) 2017/352, Member States may set the requirements in accordance with their general ports policy, any such requirements must not render ineffective the exercise of the option provided to the managing body of the port or the competent authority under that provision."
