STATEMENT 23/01

Concerning the general Decision

"The Council and the Commission note that the excise rebate scheme for disabled drivers in Ireland is designed to target the needs of a particular vulnerable sector and that this aspect will be taken fully into account when it comes to a renewal of the derogations in the Decision in due course."

STATEMENT 24/01

Re Article 16 (2):

"The Council and the Commission agree that claims lodged by creditors of an equivalent nature must be regarded as equivalent claims."

STATEMENT 25/01

"The Council and the Commission state that the provisions of this Directive concerning jurisdiction and civil proceedings were approved in the light of (a) the fact that it was necessary to supplement the corresponding provisions of the Council Regulation on Insolvency Proceedings and to ensure consistency with those provisions whilst taking account of the specific nature of credit institutions, and (b) the role played by this Directive insofar as it completes the framework for supervision and control exercised by the home Member State over credit institutions established in the Community, which was introduced under the First and Second Banking Directives (77/780/EEC and 89/646/EEC) and under the Directive on deposit-guarantee schemes (94/19/EEC). The present Directive does not therefore establish any general competence enabling the Community to dictate rules on jurisdiction and civil proceedings."

STATEMENT 26/01

Re Article 18:

"The Council and the Commission state that Member States may provide that creditors shall also be entitled to express an opinion on the serious decisions to be taken by liquidators in the course of winding-up proceedings and especially on the question of whether to continue current proceedings or open fresh proceedings."

STATEMENT 27/01

Statement by the Belgian delegation

"Belgium notes the Commission's report on Bulgaria, which states that Bulgaria has made substantial efforts in recent years both with regard to the visa system and in the wider context of preparing for its accession to the European Union, and has undertaken to continue those efforts."

STATEMENT 28/01

Statement by the Spanish Delegation

"The Spanish delegation considers the adoption of this Regulation on nuts to be of great political, economic and social interest to Spain and of strategic importance for the European Union, since the disappearance of the crop in the European Union would imply a monopoly on the Community market for the United States of America as regards almonds and for Turkey as regards hazelnuts.

Approval of this Regulation means that the plans which came to an end in the year 2000 will receive the current aid for a further year, without which continued growing of the crop would not be viable.

Nevertheless, the general mechanisms envisaged in the common organisation of the market in fruit and vegetables, in particular the operational funds, have proved inadequate to regulate the nuts sector in the absence of adequate external protection.

The Spanish delegation therefore considers that the report from the Commission to the Council on the application of Regulation (EC) No 2200/96 on the common organisation of the market in fruit and vegetables should examine in greater depth the problem of the nuts sector and put forward the necessary proposals to ensure its continued existence. These proposals should envisage permanent aid for the sector, to replace the current improvement plans, and should apply to the areas included both in the Plans that came to an end in 2000, which are now being extended, and in those which will come to an end as from 2001."
