Notice on the temporary restriction on non-essential travel to the EU and the notice of the temporary reintroduction of border control at the internal borders of Estonia

Dear colleagues,

Pursuant to the Regulation no 78 of the Government of Estonia as of 15 March 2020, the crossing of the external border for the purpose of entering Estonia has been temporarily restricted due to the Covid-19 pandemic. The measures took effect on 17 March 2020 and shall apply until the Regulation is changed.

In addition, following the Regulation no 15 of the Government of Estonia as of 15 March 2020 on the temporary reintroduction of border control at internal borders, Estonia reintroduced border control at land, sea and air borders of the Republic of Estonia as of 17 March on the basis of Article 28 of the Regulation (EU) 2016/399, on a Union Code on the rules governing the movement of persons across borders (Schengen Borders Code). Controls were prolonged several times, most recently until 17 May 2020.

As the current epidemiological situation in Europe and worldwide remains fragile, Estonia considers the temporary reintroduction of border control as essential, proportionate and adequate measure for the protection of public health.

Hereby I am informing you that Estonia reintroduces border control at internal air and sea borders based on Articles 25 (1) and 27 of the Regulation (EU) 2016/399 (Schengen Borders Code). The reintroduction commencing on 18 May 2020 at 00:00 will be in place for 30 days and last until 23:59 on 16 June 2020. The list of border crossing points, through which it is permitted to enter or leave Estonia, is added.

The movement of persons wishing to return to their countries of residence, for the purpose of frontier work and transport of goods is not hindered and is facilitated, when possible. The temporary border control is carried out to the extent strictly necessary to prevent the further spread of Covid-19 and to ensure public order on the territory of the Republic.
