Statement by Hungary

"Hungary agrees with the French Presidency's compromise for a Council mandate on the Commission's recast proposal of the regulation on the European political parties and foundations. Indeed, we are pleased to see the Member States' accordance on protecting the European politics from external influence and on respecting the Member States' competence regarding national referendums. Through the efforts made at working group level the Council was able to make refinements in the text and addressed the issues that emerged from the Commission's proposal in terms of subsidiarity and the division of competences. Hungary is of the opinion though that the Council's work on formulating its position would be greatly facilitated if the Commission's proposals paid more attention to the compliance of the intended provisions with the Treaty-based principles.

Despite the generally positive approach to the text, Hungary considers that by comprising provisions for the national parties, the proposed Council mandate does not comply with the division of competences, thus intervenes in an area that falls within the exclusive competence of the Member States. Our position remains solid on the fact that regulating national parties is an unshared right of the Member States, thus we take this consideration primal in the interpretation of the Council mandate."

Statement by Ireland

"Ireland notes that it is intended that the Council will make a decision (authorising the opening of negotiations for an Agreement between the Council and the Parliament) (to adopt the proposed Regulation) less than 3 months after presentation of this proposed decision to the Council.

As this is a Title V measure, Protocol 21 on the Position of Ireland in respect of the area of Freedom, Security and Justice annexed to the Treaties applies and Ireland therefore has the right to opt-in to the measure.

Ireland fully supports the proposal that represents an important response to the war in Ukraine. Ireland intends to opt-in to the measure following the required government and parliamentary approvals.

Notwithstanding Protocol 21 and Ireland's right to opt-in to this regulation, Ireland has, in light of the exceptional circumstances faced and mindful of the importance of the proposed regulation in enabling Member States respond to the crisis in Ukraine, unilaterally decided to waive our right in order to facilitate the speedy adoption of the measure.

In practice, this means that Ireland will not insist, in this instance, upon its right to have 3 months within which to exercise Ireland's option to notify the President of the Council of its wish to participate in the adoption and application of the proposed Council Decision in accordance with the provisions of Article 3 of Protocol 21.

Ireland will instead opt-in pursuant to Article 4 of Protocol 21 meaning that we will opt-in after the adoption of the measure. Ireland will do this as quickly as possible. This will mean that Ireland will not be in a position to avail of the funds it will release in order to respond to the crisis in the same timeframe as other Member States and until such time as the Commission approves our subsequent Article 4 opt-in.

With this in mind, we would call on the Commission to, in due course, expedite Ireland's Article 4 opt-in to the measure in order to ensure that there is no adverse impact on Ireland's ability to use the increased flexibility to respond to crisis.

The text being considered does not include a recital reflecting Ireland's decision to opt-in pursuant to Article 4. It is understood the text being finalised by the lawyer linguists will be amended to include the correct recital. It is critical that this is the case.

Finally, it is incumbent to note that Ireland's Treaty rights again appear to have been inadequately considered in the preparation of this Regulation. While we welcome the importance and symbolism of the rapid response the proposed regulation represents, the matter of Ireland's Protocol 21 rights must be respected and considered from the outset in all future measures to which it applies, as a domestic constitutional imperative."
