Subject:	Draft DECISION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL amending Decision No 1313/2013/EU on a Union Civil Protection Mechanism (first reading) - Adoption of the legislative act

1. On 2 June 2020 the Commission sent its proposal¹, based on Articles 196 and 322(1) TFEU, to the Council.
2. The European Economic and Social Committee delivered its opinion on 29 October 2020².
3. The Committee of the Regions delivered its opinion on 14 October 2020³.
4. The European Court of Auditors delivered its opinion on 28 September 2020⁴.
5. On 27 April 2021 the European Parliament adopted its position at first reading on the Commission proposal. The outcome of voting in the European Parliament reflects the compromise agreement reached between the institutions and should, therefore, be acceptable to the Council⁵.

6. The Permanent Representatives Committee is therefore asked to confirm its agreement and to suggest that the Council:
- approve the European Parliament's position, as set out in PE-CONS 6/21, as an "A" item at a forthcoming meeting;
 - decide that the statement set out in Addendum 1 to this note be entered in the minutes of that meeting.
7. At the same time, the Permanent Representatives Committee is invited to decide, in accordance with the first subparagraph of Article 12(1) of the Council's Rules of Procedure and Article 1 of Council Decision (EU) 2021/454⁶, that the Council use the written procedure for the adoption of the abovementioned Decision if, due to the circumstances related to COVID-19, no Council meeting takes place before 12 May 2021.
8. If the Council approves the European Parliament's position, the legislative act will be adopted.

After being signed by the President of the European Parliament and the President of the Council, the legislative act will be published in the *Official Journal of the European Union*.
