STATEMENT 43/02

Statement by the Council and the Commission

"The Council and the Commission state that the one year extension of improvement plans for certain nuts and locust beans and the re-introduction for one year of the specific aid for hazelnuts adopted by the Agriculture Council on 18 March 2002 upon proposal by the Commission, are the last support measures to be taken under the current regime in place for the nut sector."

STATEMENT 44/02

Statement by the Portuguese delegation

<u>Portugal</u> considers that the Commission proposal on the nut sector, in particular as regards **future support** for the sector through rural development represents a positive approach – since the sector has a significant role in terms of the environment, biodiversity and combating desertification – which can and should be applied to other sectors that play the same role in other EU regions.

This is the case for the particular situation of the grain sector in Portugal, which must merit similar treatment from the Commission and the Council in the near future.

STATEMENT 45/02

<u>Statement by the Commission, supported by the Danish, German, Netherlands and United Kingdom delegations</u>

"The Commission gives a reminder that within the framework of its communication "A sustainable Europe for a better world: A European Union strategy for sustainable development ¹" it proposes, among other things, that the raw tobacco regime be adapted at the end of its review in 2002, so as to allow for the phasing out of tobacco subsidies while putting in place measures to develop alternative sources of income and economic activity for tobacco growers and workers, and that an early date be decided on accordingly."

STATEMENT 46/02

Statement by the Member States

"In view of the date of repeal of Regulation (EC) No 925/1999 as provided for in Article 15, Member States agree that they will endeavour to implement this Directive as soon as possible into their national laws, if possible even before the date resulting from Article 16."

STATEMENT 47/02

Statement by the Commission

"The Commission notes that the annual number of "civil subsonic jet aeroplane movements" at the airport of Gibraltar is well below the 50 000 figure established in Article 2(a) as the threshold for the application of this Directive."

STATEMENT 48/02

Joint statement by the United Kingdom and Spanish delegations

"The United Kingdom and Spain state that, in view of the Commission statement, given that the content of this Directive will not apply to the airport of Gibraltar, it does not prejudice their respective legal positions on the sovereignty dispute about the territory where Gibraltar's airport is situated, and therefore the issue of the clauses does not arise."

Explanation of Belgium's vote

"Considering that the objective of the Directive on the establishment of rules and procedures with regard to the introduction of noise-related operating restrictions at Community airports to "limit or reduce the number of people significantly affected by the harmful effects of noise" is not sufficiently met by the compromise reached between the Council and the European Parliament, Belgium cannot agree to the proposed text.

Belgium takes note that the Directive does not include a minimum standard for the protection of citizens living near airports against the harmful effects of aircraft noise, nor any obligation to act in specific situations of noise nuisance in the framework of the balanced approach. Therefore, it does not guarantee any real progress in the protection of affected people, principally for competition reasons between airports.

In this view, Belgium encourages the Commission to adopt in the near future a new proposal. This should be aimed at reducing significantly the number of people suffering from the harmful effects of civil aircraft noise, in particular by setting common and mandatory minimum standards regarding the exposure to noise. This text should encourage airports particularly affected by the noisiest aircraft to conduct the necessary assessments and take the appropriate measures in the framework of the balanced approach.

In addition, Belgium invites the Commission to assess the benefits of such an approach as part of the report required by the Directive, and to examine how to strengthen the Directive, in particular by reviewing the margin of compliance of the noisiest aircraft."
