# Draft DECISION No XX/2025 of the Trade Committee

#### of XX/XX/2025

amending Article 19.3(3) and (5) concerning amendment to the ILO Declaration on Fundamental Principles and Rights at Work and the addition of a safe and healthy working environment to the fundamental principles and rights at work of the International Labour Organization

## The Trade Committee,

Having regard to the Free Trade Agreement between the European Union and New Zealand (hereinafter, 'the Agreement'), and in particular Article 19.3(4) thereof,

#### Whereas:

- (1) The 110<sup>th</sup> International Labour Conference adopted on 10 June 2022 Resolution I, on the inclusion of a safe and healthy working environment in the International Labour Organization's (ILO) framework of fundamental principles and rights at work.
- (2) Article 19.3(4) provides that the Trade Committee, no later than at its first meeting, may adopt a decision to amend Article 19.3(3) to reflect the addition of a safe and healthy working environment to the fundamental principles and rights at work in accordance with the decision of the 110th International Labour Conference in June 2022.
- (3) Article 19.3(3) should therefore be amended by addition of a safe and healthy working environment to the fundamental principles and rights at work. In addition, the reference to the ILO Declaration on Fundamental Principles and Rights at Work in Article 19.3(3) should be updated for alignment with its most recent amendment.
- (4) Following the amendment to Article 19.3(3), the statement in the footnote of Article 19.3(5) that all Member States have ratified the fundamental conventions of the ILO has become obsolete. It therefore appears appropriate to delete the footnote in Article 19.3(5).

#### HAS ADOPTED THIS DECISION:

#### Article 1

Article 19.3(3) and (5) are amended, as set out in Annex to this Decision.

#### Article 2

The amendments set out in the Annex to this Decision shall enter into force on the first day of the sixth month following the date on which the Parties exchange written notifications certifying that they have completed their respective applicable legal requirements and procedures for entry into force of the amendments.

# Article 19.3 (3) is amended as follows:

- (1) After the words 'at its 86th Session and its Follow-up,' the words 'as amended at its 110th Session in 2022' are added.
- (2) In point (c), after the words 'the effective abolition of child labour', the word 'and' is deleted.
- (3) In point (d), after the words 'the elimination of discrimination in respect of employment and occupation', the full stop is deleted and the following ';and' is added.
- (4) Point (e) is added as follows:
  - '(e) a safe and healthy working environment'.

## Article 19.3(5) is amended as follows:

(1) Footnote 1 'The Parties note that all Member States have ratified the fundamental conventions of the ILO.' is deleted.
