Subject:	Files under the ordinary legislative procedure expected to undergo the Corrigendum Procedure in the European Parliament

---

Delegations will find in the Annex the list of files which are expected to undergo the Corrigendum Procedure in the European Parliament<sup>1</sup>. In accordance with the provisions of Article 294 of the TFEU and the Joint Declaration on practical arrangements for the co-decision procedure<sup>2</sup>, a number of informal contacts have taken place between the Council, the European Parliament and the Commission with a view to reaching an agreement on these files at first reading, thereby avoiding the need for second reading and conciliation.

Once the legal-linguistic experts have scrutinised the above-mentioned texts, and the EP plenary adopts the corresponding corrigenda, the Council should be able to approve the position of the European Parliament on that basis, thus bringing to a close the first reading for both institutions.

The acts would then be adopted in the wording which corresponds to the Parliament's position.
