**ANNEX II**

**STATEMENT 25/00**

**Statement by the Danish delegation concerning Amendment 6 – Article 4(3a)(new)**

"In the view of the Danish delegation, this provision means that, in conformity with existing Community law, social benefits cannot be paid to beneficiaries of the programme residing outside Danish territory, except where provided by Danish law. Where beneficiaries reside in Denmark, they are automatically entitled, if they otherwise fulfil the conditions for receiving the various payments, to the benefits laid down by the law on an active social policy and the law on social services."
