Subject:	Management Board of the European Foundation for the improvement of living and working conditions Appointment of Ms Guusje DOLSMA, member for the Netherlands, in place of Mr Mario VAN MIERLO, who has resigned

1. The General Secretariat of the Council has been informed of the resignation of Mr Mario VAN MIERLO as member of the Management Board of the above Foundation in the employers' representatives' category (for the Netherlands).
2. Under Article 4 of Regulation (EU) 2019/127 of the European Parliament and of the Council establishing the European Foundation for the improvement of living and working conditions (Eurofound), and repealing Council Regulation (EEC) No 1365/75¹, members of the Management Board are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2019/127 of the European Parliament and of the Council of 16 January 2019 establishing the European Foundation for the improvement of living and working conditions (Eurofound), and repealing Council Regulation (EEC) No 1365/75², and in particular Article 4 thereof,

Whereas:

- (1) By its Decision of 28 March 2023³, the Council appointed the members and alternate members of the Management Board of the European Foundation for the improvement of living and working conditions for the period from 1 April 2023 to 31 March 2027.
- (2) A seat as member in the employers' representatives' category has fallen vacant as a result of the resignation of Mr Mario VAN MIERLO.
- (3) The employers' organisation BusinessEurope has nominated a candidate for the vacant seat,

HAS ADOPTED THIS DECISION:
