– Intention not to raise objections to a delegated act

The SCA confirmed that it has no intention to object to this delegated act and it assumed that the Council does not intend to object to it either.

– Preparation of the general approach

The SCA held a discussion based on the Presidency compromise text (8322/15), in order to reach a general approach at the next Council on 11 May. A number of delegations reiterated that some of their concerns have not been taken on board in the text. Following a delegation's request to introduce "pollen" in the Annex I of the Regulation, the Commission indicated that "pollen" is covered by Annex I to the Treaty. The Presidency stressed that a delicate balance has almost been reached on the main sensitive issues. With a view to facilitating a compromise, the Presidency suggested some slight modifications in the text. Some remaining outstanding issues need to be solved at the next "Agriculture and Fisheries" Council.

The SCA reached broad agreement on the draft Council conclusions on CAP simplification and agreed to forward them to the "Agriculture and Fisheries" Council on 11 May with a view to their adoption ("B" item).

The SCA endorsed the draft updated EU Guidelines for the G20 Agriculture Ministers meeting in Istanbul as amended in doc. 8453/15, which will be submitted to the Council for adoption on 7 May ("A" item).

The Commission presented its Financial Discipline proposal, which was adopted on 26 March and which was discussed previously in the Agrifin Working Party on 15 April.
