Question for written answer E-000585/2022/rev.1 to the Council Rule 138 Cornelia Ernst (The Left)

Subject: Improper use of Interpol alerts

The ETIAS Regulation regulates, among other things, search requests to the Stolen and Lost Travel Documents database (SLTD) and the Travel Documents Associated with Notices database (TDAWN). Europol should also cooperate more closely with Interpol. At the request of the Council, the Commission is also negotiating opening clauses for Europol, Frontex, Eurojust, eu-LISA and the European Public Prosecutor's Office with regard to access to Interpol databases.

- 1. How do the Council and the Member States intend to ensure that searches of Interpol databases via ETIAS or by Europol do not encourage the misuse of searches?
- 2. What possibilities does the Council's see for supporting the Member States in exchanges over improper search requests, and what other options has Interpol proposed in this regard?
- 3. Has the Commission invited the Commission to support the Member States in detecting improper search requests and to organise a workshop, for example, to determine further steps?

EN E-000585/2022 Reply

Article 12 of Regulation (EU) 2018/1240 establishing a European Travel Information and Authorisation System (ETIAS) provides that ETIAS 'shall query the Interpol Stolen and Lost Travel Document database (SLTD) and the Interpol Travel Documents Associated with Notices database (TDAWN) [...] in such a way that no information shall be revealed to the owner of the Interpol alert', making the misuse of queries launched against Interpol databases impossible.

The negotiating mandate for a cooperation agreement between the EU and Interpol referred to by the Honourable Member provides that, in the course of the negotiations, the Commission should aim to achieve, inter alia, the objective to provide the safeguards and guarantees needed to authorise controlled access to Interpol's databases in full compliance with EU data protection requirements and fundamental rights.

The Council has not asked the Commission to organise a workshop on the issue referred to by the Honourable Member. Interpol has not proposed any other options.
