Subject:	Proposal for a Directive of the European Parliament and of the Council amending Directive 2000/60/EC establishing a framework for Community action in the field of water policy, Directive 2006/118/EC on the protection of groundwater against pollution and deterioration and Directive 2008/105/EC on environmental quality standards in the field of water policy - Preparation for the trilogue

I. <u>INTRODUCTION</u>

1. On 22 of June 2022, the Commission adopted a proposal for a Directive amending Directive 2000/60/EC establishing a framework for Community action in the field of water policy (WFD), Directive 2006/118/EC on the protection of groundwater against pollution and deterioration (GWD) and Directive 2008/105/EC on environmental quality standards in the field of water policy (EQSD)¹. The proposal aims to update the Annexes of these directives containing the lists of pollutants and quality standards, to improve monitoring of chemical mixtures, streamline future updates according to scientific findings, improve access to, transparency and re-use of data and set new standards for a series of substances of emerging concern.

- 2. The <u>Economic and Social Committee</u> adopted its opinion on the proposal on 22 February 2023.
- 3. In the European Parliament, the Committee on the Environment, Climate and Food Safety (ENVI) is responsible for the file. The European Parliament adopted its position at first reading on 24 April 2024, with 452 votes in favour, 43 votes against and 83 abstentions. Following the elections of the European Parliament, Javi LÓPEZ (S&D) was appointed rapporteur.
- 4. On 19 June 2024, <u>Coreper</u> adopted a mandate for negotiations with the European Parliament.³
- 5. The Working Party on the Environment (WPE) examined the Parliament's amendments at its meeting on 3 September 2024. The first trilogue on the proposal was held on 28 January 2025. Subsequently, 17 meetings took place between the institutions at technical level. On 4 March 2025, the Presidency debriefed the WPE on the state of play of the negotiations. On 29 April 2025, the WPE examined the Presidency's compromise proposals for a revised mandate.

II. PRESIDENCY COMPROMISE PROPOSALS WITH A VIEW TO THE TRILOGUE

- 6. The second trilogue is scheduled for 20 May 2025 and is expected to:
 - confirm the results of work carried out at the technical level (the green rows of the annexed 4-column table);
 - reach agreement on a number of political issues related to substantive provisions on four clusters: a) watchlists, b) monitoring, c) reporting and d) horizontal issues, including the reintroduction of Articles 16 and 17.

7. With the aim to achieving a balanced text on the identified clusters, the Presidency puts forward the compromise proposals described below and further detailed in the updated four-column table annexed to this Note.

a) Watchlists cluster: Groundwater and surface water watchlists

- 8. For the **groundwater watchlist**, the Presidency compromise consists of the following main elements:
 - The watchlist will remain capped, and not opened as requested by the Parliament. The watchlist will contain a maximum of 5 substances or group of substances, however, "indicators of pollutants", as defined in the footnote to the provision, are added to the watchlist, as amended by the Parliament;
 - The expression, "total number of individual compounds" is deleted in order not to make the capping too strict but the original obligation that "methods shall not entail excessive costs" is kept;
 - Microplastics and antimicrobial resistance genes (ARGs) are to be included in the watchlist, provided that reliable methods of sampling and analysis are available. At the request of the Parliament, these methods are to be developed by the Commission within 18 months from the adoption of the Directive. In addition, an acknowledgement is added that these substances will not be retained for the following period of 3 years if progress has not been made on the development of a risk assessment method;
 - The compromise proposal includes the Council's mandate on the content of the ECHA report, including the added provision on recommendations from the Common Implementation Strategy (CIS) Working Groups;
 - The first watchlist is to be established within 2 years. The monitoring period of the substances included in the watchlist has the duration of 24 months and is to start 6 months after the adoption of the watchlist, but a precision is added that Member States do not need to start sampling and analysis immediately after that date. Substances from the list are to be monitored at least once per year;

- The revision of the watchlists is to be kept at every 36 months, as foreseen in the Commission's proposal and Council's mandate;
- The number of monitoring stations is increased in comparison to the Commission's initial proposal but remains less than in the Parliament's amendment (2 stations + one for every 45000 km² of groundwater bodies).
- 9. The compromise proposal for the **surface water watchlist** is aligned with the groundwater watchlist in relation to the capping (but with a maximum limit of 10 substances), microplastic and ARGs, the content of the ECHA report, the starting date for the monitoring period and revision frequency. In addition, the Council's mandate in relation to the frequency of monitoring of sediment and biota is included in the compromise text, as is a recital on green transition added at the request of the Parliament.
- b) Monitoring cluster: Frequency of uPBTs monitoring, seasonal variations in monitoring, digitalisation and real-time online monitoring and the Joint Monitoring Facility
 - 10. In relation to the **monitoring frequency of substances behaving like ubiquitous PBTs**, the compromise text further precises that Member States may monitor these substances less intensively than is required for priority substances, but such monitoring should take place at least every three years, unless the use or emission of the substance, or technical knowledge and expert judgment, justify another interval.
 - 11. On **seasonal monitoring**, the Presidency compromise text proposes limited changes to Annex V of the WFD, in order for Member States to take into account peaks of substance use when planning their monitoring. This compromise relates mainly to the use of pesticides.
 - 12. In relation to **digitalisation and real-time online monitoring**, also limited changes are proposed in the form of recital (31) and to Annex V to include a voluntary encouragement for digitalisation of monitoring. The changes do not impose new obligations on the Member States.

- 13. On the **Joint Monitoring Facility**, both co-legislators provisionally agreed to move all provisions to the WFD, to keep the voluntary nature of the facility and to adopt a graduated approach, that is first the assessment of feasibility by the Commission and then the possible establishment of the Facility. The compromise text is based on the Council's mandate.
- c) Reporting cluster: Reporting of monitoring and status data and interim reports on the programme of measures, reporting of national threshold values and environment quality standards (EQS) for River Basin Specific Pollutants (RBSPs), and maps and indicators of progress
 - 14. As the European Parliament showed flexibility to accept the Council's mandate on the reporting of status data and on deleting the interim reports on the programme of measures, matters of most importance for the Member States, the Presidency is asking for flexibility to have more frequent reporting of monitoring data. Together with the indicators of progress, such increased frequency of reporting of monitoring data would also contribute to facilitate communication on progress.
 - 15. In relation to the **reporting of national threshold values and EQS for RBSPs**, the compromise text proposes to keep, as a general rule, the reporting within the River Basin Management Plans (RBMPs), with the exception of the first national threshold values and RBSPs EQS set after the adoption of this Directive, for which the specific deadline, aligned with the transposition period [of 18/24months] is proposed.
 - 16. The Council's mandate on **maps** was accepted.
- d) Horizontal issues cluster: measures at source, transboundary cooperation and the rejection of the RBMP by the Commission, as well as the reintroduction of Articles 16 and 17 WFD

- 17. In relation to measures **at source**, as a response to the multiple amendments proposed by the Parliament on this issue, a single new paragraph (1a) is added to Article 11 of the WFD, emphasising that Member States, in their programme of measures, have to first consider source-control measures, in accordance with the relevant Union sectoral legislation, and then, where necessary, measures to reduce the risk from existing pollution. This compromise is also dependant on the reintroduction of Article 16 and the obligation put on the Commission in this regard, in accordance with Article 16(6) WFD as reintroduced by the Council's mandate.
- 18. On **transboundary cooperation**, the compromise proposal deletes the relevant provisions from Article 3 WFD and inserts a new paragraph (5) under Article 12 WFD with a similar content. The main difference being that when faced with exceptional circumstances, in particular extreme floods, prolonged droughts or significant pollution incidents, in addition to informing other affected Member States and international riverbasin coordination authorities, a Member States must also inform the Commission, as originally foreseen in the Commission's proposal.
- 19. On the proposed Parliament amendment giving the possibility for **the Commission to reject the RBMPs**, the Presidency has made clear during the technical negotiations that such a possibility could not be included in the WFD. As a compromise, a new point 5 is added to part B of Annex VII (WFD), so that in their updated RBMPs, Member States are to provide a summary of measures adopted to take into account the suggestions for improvement made by the Commission to the previous RBMPs.

- 20. Finally, the last element of the compromise proposal to be discussed at the second trilogue is the reintroduction of Articles 16 and 17 of the WFD. The Commission considered that these two articles were obsolete since its amending proposal foresaw delegated acts (DA) for updating the lists of pollutants and their values, contained in the Annexes of the GDW and the WFD. However, Member States consider that the Annexes are a substantial element of both directives. Therefore, the Council's mandate reintroduces these Articles not only for updating the Annexes of both directives by ordinary legislative procedure (OLP) but also to keep the obligation for the Commission to propose legislative acts to address the progressive reduction of discharges, emissions and losses of priority substances, and, in particular, the cessation or phasing-out of discharges, emissions and losses of priority hazardous substances, including a timetable for Member States to phase out the use of those hazardous substances, or their primary emissions, within 20 years of their designation.
- 21. To be noted that during the upcoming trilogue, the co-legislators will confirm the general principle to reintroduce Articles 16 and 17, however, the specific issues of the process (OLP or DA) and frequency for review and updating (4/6 years) of the Annexes of both directives will remain bracketed and will be addressed at a later stage.

III. <u>CONCLUSION</u>

22. The <u>Permanent Representatives Committee</u> is invited to examine the Presidency's compromise text as set out in this note and annexed four-column table with a view to provide the Presidency with a mandate for the negotiations with the European Parliament at the upcoming trilogue, scheduled to take place on 20 May 2025.
