a) Regulation on CAP Strategic Plans

<u>The SCA</u> took note of the information provided by the Presidency on the outcome of the last trilogue held on 30 April on the basis of the four-column document set out in document 8414/21 + ADD1, and of the comments from delegations and the Commission.

The discussion focused on the green architecture, certain aspects of rural development, the CAP's social dimension on the basis of a European Parliament non-paper set out in 8207/21, capping/degressivity/redistributive payments as well as climate and biodiversity tracking.

<u>The Presidency</u> will take into account the outcome of this meeting for the continuation of the negotiations with the European Parliament.

<u>The SCA</u> also took note of the information provided by Belgium on the transfer of multiannual commitments going beyond the current programming period to eco-schemes, as set out in document 8480/21, of the support from many other delegations and of the response from the Commission.
