## INTRODUCTION AND BACKGROUND

- 1. On 28 March 2025, the Commission transmitted the above-mentioned proposal to the Council.
- 2. Directive 2009/16/EC of the European Parliament and of the Council<sup>1</sup> sets out the Union regime on port State control. That regime is based on the pre-existing structure of the Paris Memorandum of Understanding on port State control ('the Paris MOU')<sup>2</sup>.

- 3. Certain procedures, tools and activities, such as instructions, of the Paris MOU are brought into Union law through Directive 2009/16/EC and therefore certain decisions taken by the Port State Control Committee ('PSCC') of the Paris MOU become binding on EU Member States.
- 4. Until 2015, the EU position to be adopted in the PSCC was decided on an annual basis. As the internal rules of the Paris MOU make it difficult to establish a position to be adopted, on behalf of the Union, in a timely manner for each individual meeting of the PSCC, the Commission in 2015 proposed a multi-annual framework decision, covering the period 2016–2019, which was duly adopted by the Council<sup>1</sup>. That Council Decision was followed by a second multiannual framework decision for the period 2020–2024<sup>2</sup>.
- 5. This draft Council Decision, if adopted, would provide a multi-annual framework for the position to be adopted, on the Union's behalf, within the PSCC of the Paris MOU, for the period 2025 to 2029.

## WORK WITHIN THE COUNCIL PREPARATORY BODIES

- 6. The proposal was examined by the Shipping Working Party at its meetings on 7 and 14 April 2025. At that last meeting, some changes were made to the proposal which were subjected to an informal silence procedure, with no objections expressed by delegation.
- 7. Following the agreement reached at working party level, the text of the draft Council Decision was revised by the Council's legal-linguistic services.<sup>3</sup>

## **ACTION REQUESTED**

8. The Permanent Representatives Committee is invited to examine and endorse the draft decision, as set out in document ST 8474/25, prepared by the legal-linguistic experts, and its addendum, and transmit it to the Council with a view to adoption at a future session.
