Subject: Council Decision appointing alternate members of the Committee of the Regions for the period from 8 June 2026 to 25 January 2030 and amending Decision (EU) 2025/71
- Adoption

1. The previous term of office of the members and alternate members of the Committee of the Regions ended on 25 January 2025¹.
2. Under Article 305 TFEU, the Council appoints members and alternate members of the Committee of the Regions for a term of five years, acting by a qualified majority on proposals by the respective Member States.
3. By document 9007/24, the General Secretariat of the Council invited Member States to submit their proposals for candidates for appointment as members and alternate members of the Committee of the Regions for the period from 26 January 2025 to 25 January 2030.

4. On 10 December 2024, the Council adopted Decision (EU) 2025/71² appointing the members and alternate members of the Committee of the Regions for the period from 26 January 2025 to 25 January 2030. That Decision appointed, for the period from 26 January 2025 to 25 January 2030, the members and alternate members proposed by the Estonian, Irish, Croatian, Cyprus, Latvian, Luxembourgish, Maltese, Dutch, Austrian, Portuguese, Slovenian, Slovak, Finnish and Swedish Governments. Decision (EU) 2025/71 also appointed for the same period 12 members and nine alternate members proposed by the Czech Government, seven members and nine alternate members proposed by the Danish Government, 23 members and 19 alternate members proposed by the German Government, 11 members and 12 alternate members proposed by the Greek Government, 20 members and 20 alternate members proposed by the Spanish Government, 22 members and 24 alternate members proposed by the Italian Government, 21 members and 20 alternate members proposed by the Polish Government and nine members and nine alternate members proposed by the Romanian Government.
5. On 21 January 2025, the Council adopted Decision (EU) 2025/201³ appointing, for the same period, the members and alternate members of the Committee of the Regions proposed by the Bulgarian, Lithuanian and Hungarian Governments. Decision (EU) 2025/201 also appointed for the same period 10 members and 10 alternate members proposed by the Belgian Government, 24 members and 23 alternate members proposed by the French Government. Furthermore, Decision (EU) 2025/201 appointed two members and one alternate member proposed by the Danish Government, one of the members having initially been appointed as an alternate member by Decision (EU) 2025/71. It also appointed one alternate member proposed by the Italian Government following the resignation of an alternate member appointed by Decision (EU) 2025/71.

On 18 February 2025, the Council adopted Decision (EU) 2025/378⁴ appointing, for the period from 18 February 2025 to 25 January 2030, two members and two alternate members of the Committee of the Regions proposed by the Belgian Government, two alternate members proposed by the German Government, one member proposed by the Greek Government, one member and one alternate member proposed by the Spanish Government, two members proposed by the Italian Government, six members and six alternate members proposed by the Romanian Government, and one alternate member proposed by the Polish Government. It also appointed one German member proposed by the German Government following the resignation of a member appointed by Decision (EU) 2025/71.
7. On 13 May 2025, the Council adopted Decision (EU) 2025/954⁵. By that Decision, it appointed, for the period from 13 May 2025 to 25 January 2030, one member and one alternate member proposed by the German Government, and three alternate members proposed by the Czech Government. Furthermore, by Decision (EU) 2025/954, the Council appointed one member proposed by the German Government following the end, prior to the start of the current term of office of the Committee of the Regions, of the mandate on the basis of which a German member was proposed for appointment and appointed by Decision (EU) 2025/71. It also appointed one member proposed by the Austrian Government following the end, prior to the start of the current term of office of the Committee of the Regions, of the mandate on the basis of which an Austrian member was proposed for appointment and appointed by Decision (EU) 2025/71.

8. On 10 October 2025, the Council adopted Decision (EU) 2025/2119⁶. By that Decision, it appointed, for the period from 10 October to 25 January 2030, two alternate members proposed by the German Government.
9. By letter of 21 November 2025⁷, the Secretary-General of the Committee of the Regions notified the Council of the end of the national mandate on the basis of which Mr Rogério David SÁDIO DA SILVA and Ms Cristina de Fátima SILVA CALISTO had been appointed as alternate members of the Committee of the Regions for the period from 26 January 2025 to 25 January 2030. Following the end of these mandates on 9 December 2024 and 4 March 2024 respectively, the Portuguese Government proposed by letter of 13 April 2026⁸ that Ms Sónia Isabel FERNANDES SANFONA CRUZ MENDES and Ms Filomena PASCOAL SINTRA be appointed as alternate members of the Committee of the Regions.
10. The Permanent Representatives Committee is therefore invited to confirm its agreement on the text of the Decision, as set out in document 8661/26, and to suggest that the Council adopt that Decision as an 'A' item at a forthcoming meeting.
11. The appointment of the alternate members of the Committee of the Regions by the Decision set out in document 8661/26 will be followed at a later date by the appointment of another alternate member, in relation to whom the proposal for appointment was not communicated to the Council by the Member State concerned before 1 May 2026.
