Subject:	Appointment of an official to a post of Director-General at the General Secretariat of the Council

- *Approval*
- *Decision to use the written procedure*

The post of Director-General of Directorate-General TREE (grade AD 15) will become vacant on 1 October 2020.

The vacancy notice was published internally, interinstitutionally, externally and also sent to the Permanent Representations of the Member States. Forty (40) applications were received within the given deadline¹.

In accordance with Article 1(1)(b) of the Council Decision (EU) 2017/262² it is for the Council to take a decision on a proposal from the Secretary-General.

To prepare such proposal the Secretary-General appointed a Selection Committee to assist him in making a comparative assessment of the applications received. The Committee examined all applications and interviewed nine (9) candidates.

On the basis of the Selection Committee's evaluation and examination of the files of the candidates, the Secretary-General proposes, for the reasons explained orally to the Permanent Representatives Committee on 12 June 2020, that Mr Peter JAVORČÍK be appointed as a probationary official grade AD 15 to the post of Director-General of the Directorate General TREE of the General Secretariat of the Council.

In view of above, the Permanent Representatives Committee is invited to:

- confirm its agreement on the text of the Council decision appointing an official to a post of Director-General at the General Secretariat of the Council of the European Union (set out in the Annex), subject to its revision by lawyers-linguists;
- decide, in accordance with the first subparagraph of Article 12(1) of the Council's Rules of Procedure and Article 1 of Council Decision 2020/430, that the Council uses the written procedure for its adoption.

Having regard to the Staff Regulations of Officials of the European Union, laid down in Council Regulation (EEC, Euratom, ECSC) No 259/68¹, and in particular Articles 1, 4 and 29(2) thereof,

Having regard to Council Decision (EU) 2017/262 of 6 February 2017 determining, for the General Secretariat of the Council, the appointing authority and the authority empowered to conclude contracts of employment, and repealing Decision 2013/811/EU², and in particular Article 1(1)(b) thereof,

Having regard to the vacancy notice which was published internally, interinstitutionally and externally and also sent to the Permanent Representations of the Member States,

Having regard to the proposal from the Secretary-General of the Council,

Whereas the establishment plan annexed to Section II (European Council and Council) of the general budget allows for the appointment of an official to a post of Director-General,

HAS ADOPTED THIS DECISION:

Article 1

Mr Peter JAVORČÍK is hereby appointed as from 1 October 2020 as probationary official to the post of Director-General (AD 15) of the Directorate-General for Environment, Education, Transport and Energy (TREE) of the General Secretariat of the Council, subject to compliance with point (e) of Article 28 of the Staff Regulations of Officials of the European Union.
