RE PROLONGATION OF INTERNAL BORDER CONTROL AT SEA AND AIR BORDERS

Dear Colleagues,

In the notification of 14 March 2020, the Republic of Lithuania informed about the decision of the Government to temporarily reintroduce border control at all internal land, sea and air borders in accordance with Article 28 of the Regulation (EU) 2016/399 of the European Parliament and of the Council of 9 March 2016 on a Union Code on the rules governing the movement of persons across borders (Schengen Borders Code). In the notification of 6 May 2020, the Republic of Lithuania informed about the decision of the Government to temporarily reintroduce border control at all internal land, sea and air borders in accordance with Articles 25 and 27 of Schengen Borders Code. After thorough examination of the epidemiological situation based on most recent information and data evidence in the Republic of Lithuania, neighbouring States and across Europe, the Government of the Republic of Lithuania decided that border control at the internal land border with the Republic of Poland may be lifted, however, the grounds for internal border control at sea and air borders continue to be valid, making it necessary to prolong border control in accordance with the paragraph 3 of Article 25 of Schengen Borders Code.

The prolongation of border control at sea and air borders will take effect from 17 June 2020 00:00 and will last until 16 July 2020 24:00.

The border control will be carried out at international airports and the seaport of Klaipėda.



The border control at internal land border with the Republic of Poland will be lifted as of 12 June 2020 00:00.

Please rest assured that the scope and duration of the internal border control will be limited to what is strictly necessary. The Republic of Lithuania will continue to carefully monitor and assess the development of the situation, as well as the impact and proportionality of the measures taken.
