- The **national correspondent for Eurojust** under Article 12(1) of the Council Decision of 28 February 2002 setting up Eurojust with a view to reinforcing the fight against serious crime (OJ L 63, 6.3.2002, p. 1), as amended by the Council Decision of 16 December 2008 (OJ L 138, 4.6.2009, p. 14), is **Dr Johannes Martetschläger**, senior public prosecutor at the Federal Ministry of Justice.
- The new **Eurojust national correspondent for terrorism matters** under Article 2(2) of Council Decision 2005/671/JHA is **Stefanie Schön**, public prosecutor at the Vienna public prosecutor's office. Ms Schön replaces Mr Hans-Peter Kronawetter in this position and will work together with **Dr Michael Klackl, deputy director** of the Vienna senior public prosecutor's office.
- The **national correspondent for the European Judicial Network (EJN)** under Article 2(3) of the Council Decision of 16 December 2008 on the European Judicial Network (OJ L 348, 24.12.2008, p. 130) is **Dr Johannes Martetschläger**, senior public prosecutor at the Federal Ministry of Justice.

- The **tool correspondent for the European Judicial Network (EJN)** under Article 2(4) of the Council Decision of 16 December 2008 on the European Judicial Network (OJ L 348, 24.12.2008, p. 130) is **Dr Stefan Benner**, senior public prosecutor at the Federal Ministry of Justice.
- Ms Christine Gödl, judge and adviser at the Federal Ministry of Justice, is nominated as an additional contact point under Article 1(1) of Council Decision 2002/494/JHA of 13 June 2002 setting up a European network of contact points in respect of persons responsible for genocide, crimes against humanity and war crimes (OJ L 167, 26.6.2002, p. 1), alongside Dr Johannes Martetschläger, senior public prosecutor at the Federal Ministry of Justice, who has already been nominated.
- **Ms Andrea Rohner**, public prosecutor and adviser at the Federal Ministry of Justice, is nominated as an additional **expert** in the **network of experts on joint investigation teams** in accordance with Council document 11037/05 CRIMORG 67 ENFOPOL 88, as a counterpart to **Dr Johannes Martetschläger**, senior public prosecutor at the Federal Ministry of Justice, who has already been nominated.
