First, the Chair debriefed the Committee on the outcome of the first informal trilogue on 11 April 2012, stressing its exploratory nature. He presented to the European Parliament side the 11 principles underlying the Council's preliminary position and stressed the Council commitment to reaching agreement by end of June on an ambitious and flexible framework. The rapporteur outlined the main points of interest to the EP (binding national targets, pre-financing of measures, role of private buildings, leading role of public sector, 1.5 % for Art. 6, step up consumer role, set-aside under the ETS) and criticised certain elements of the Council position, e.g. reduced scope of Art. 4, wide exemptions under Art. 6 or statistical transfers. Next trilogue is foreseen on 24 April 2012.

Referring to a non-paper tabled by the Commission on what would be achieved in terms of energy efficiency by the current text of the Council the Chair recalled that the Council objective is for the EED to make a significant contribution to the 20% target while the Commission and the EP consider that the EED should bridge the full gap.

In order to prepare this next trilogue the Presidency submitted to the Committee document 8712/12 comprising a series of additional elements concerning Art. 7, 8, 11, 12, 13, 14 and 15 as well as suggestions based on EP proposed Art. 8a and 13a. Following some redrafting the Committee could agree to a mandate based on the fourth column of document 8712/12.

The UK delegation made the following declaration for the minutes:

"The UK does not regard the draft Horizontal Regulation as a development of the Schengen acquis but can accept that it will support the application of the draft Regulation establishing, as part of the Internal Security Fund, the instrument for financial support for external borders and visa.
