 To improve the security posture of the European Council and the Council, in June 2021 Coreper agreed to launch a secure videoconferencing (VTC) project to equip the President and members of the European Council, the Permanent Representations, and Ministries of Foreign Affairs of Member States and the Commission with a videoconferencing solution capable of handling EU classified information up to and including the level of SECRET UE/EU SECRET (see doc. ST 9457/21 + COR1).

## II. STATUS OF THE SECURE VIDEOCONFERENCING PROJECT

- 4. GSC has been implementing the secure videoconferencing project on the basis agreed by Coreper in 2021, including the steps for full system accreditation, working closely with the Council's Coordination Committee for Communication and Information Systems (Coordination Committee for CIS) and the Council's Security Committee and its relevant subgroups.
- 5. Based on the high-level business requirements, the high level business security requirements, a high and low level design have been produced and agreed by the Coordination Committee for CIS, and cryptographic specifications have been drawn up and agreed by the Council's Security Committee.
- 6. In parallel, the envisaged solution has undergone technical and functional operational testing.
