Θέμα : Πρωτοβουλία της ομάδας των 7 (G 7) για την τυποποίηση και την απλούστευση των τελωνειακών διαδικασιών

Εισαγωγή

Κατά τις συνεδριάσεις της στις 9 και 16 Μαρτίου 1999, η Ομάδα χαιρέτισε και υποστήριξε την πρωτοβουλία της ομάδας των 7 (G 7) για την τυποποίηση και την απλούστευση των τελωνειακών διαδικασιών και σημείωσε τα αποτελέσματα των διεξαχθεισών διαπραγματεύσεων.

Στόχος

Η γαλλική, η γερμανική, η ιταλική και η βρετανική αντιπροσωπεία και η Επιτροπή καλούν την **Ομάδα Οικονομικών Θεμάτων (τελωνειακή ένωση)** να εγκρίνει την επιτευχθείσα πρόοδο σε επίπεδο G 7 (βλέπε Παραρτήματα 1 έως 3).

Εισαγωγή

Στο Παράρτημα 1 (στήλη IM) περιλαμβάνεται ο κατάλογος ανώτατων προδιαγραφών όσον αφορά τα στοιχεία που μπορούν να ζητούνται για τα εισαγόμενα "συνήθη" αγαθά οικιακής χρήσης. Ένα τμήμα του εν λόγω **Παραρτήματος 1** (στήλη CR) περιλαμβάνει τα στοιχεία που κρίνονται απαραίτητα προκειμένου να αποφασισθεί εάν τα αγαθά θα πρέπει να διεκπεραιωθούν με απλουστευμένη διαδικασία δύο φάσεων.

Τα στοιχεία που πρέπει να περιληφθούν σε συνοπτική διασάφηση περιλαμβάνονται στο

Παράρτημα 2.

Προκειμένου να διευκολυνθεί η αξιολόγηση των εν λόγω συνόλων στοιχείων (Παραρτήματα 1 και 2), στο **Παράρτημα 3** συγκεντρώνονται όλα τα στοιχεία που μπορούν/πρέπει να ζητούνται επί του παρόντος (είτε στο ενιαίο διοικητικό έντυπο είτε στην δήλωση τελωνειακής αξίας DV 1) κατά την εισαγωγή για οικιακή χρήση σύμφωνα με τις ισχύουσες τελωνειακές διατάξεις στην Κοινότητα (συνήθης διαδικασία), αλλά τα οποία δεν περιλαμβάνονται στα σύνολα στοιχείων εισαγωγών της G 7. Η περιγραφή των καταλόγων περιλαμβάνεται στο **παράρτημα 4**.

Προοπτική

Η Τεχνική Ομάδα G 7 προτίθεται να **αναπτύξει ηλεκτρονικά μηνύματα** χρησιμοποιώντας τα πρότυπα EDIFACT των Ηνωμένων Εθνών βάσει των συνόλων στοιχείων που αναφέρονται στα παραρτήματα 1 και 2. Οι σχετικές εργασίες θα συνεχισθούν κατά προτεραιότητα, αρχίζοντας με τη συνεδρίαση της προαναφερόμενης Ομάδας στις 17 έως 21 Μαΐου 1999. Συνεχίζονται οι συζητήσεις σχετικά με τα σύνολα στοιχείων για τις εξαγωγές καθώς και με το σύνολο στοιχείων για τη διαδικασία διαμετακόμισης. Η Ομάδα του Συμβουλίου θα τηρηθεί δεόντως ενήμερη σχετικά με την περαιτέρω πρόοδο.

Αρχές σχετικά με τις εργασίες

Τα αποτελέσματα σε επίπεδο G 7 βασίζονται στο ακόλουθο σκεπτικό:

1. Τα σύνολα στοιχείων θα χρησιμοποιούνται αποκλειστικά στα πλαίσια νέας κατηγορίας **απλουστευμένων διαδικασιών**, για την εφαρμογή των οποίων οι αρμόδιες αρχές δύνανται να χορηγούν άδεια.

2. Οι εν λόγω διαδικασίες εφαρμόζονται αποκλειστικά για "**συνήθη**" **αγαθά**, έννοια η οποία δεν έχει ακόμη διατυπωθεί οριστικά. Κατά τη γενική άποψη πρόκειται για αγαθά τα οποία δεν υπόκεινται σε ιδιαίτερες προϋποθέσεις κοινοποίησης (όπως ισχύει π.χ. για ορισμένα αγαθά που υπόκεινται σε απαγορεύσεις και περιορισμούς), τα οποία δεν ενέχουν ιδιαίτερο κίνδυνο απάτης και τα οποία δεν υπόκεινται σε ειδική εποπτεία (π.χ. για λόγους εμπορικής πολιτικής).
3. Στόχος είναι να καταρτισθούν σύνολα στοιχείων για τις **ηλεκτρονικές διασαφήσεις** τις οποίες οι διοικήσεις θα **διεκπεραιώνουν ηλεκτρονικά**.
4. Στόχος είναι οι εμπορευόμενοι να κοινοποιούν **άπαξ** τα στοιχεία στις διοικήσεις. Για παράδειγμα, η διοίκηση θα μπορούσε να χρησιμοποιεί την μηχανογράφηση για τη χρήση των στοιχείων που υποβάλλονται με συνοπτική διασάφηση για τον εκτελωνισμό αγαθών οικιακής χρήσης.
5. Τα σύνολα στοιχείων (Παραρτήματα 1 και 2) θα μετατρέπονται σε **τυποποιημένο ηλεκτρονικό μήνυμα** που θα χρησιμοποιούν όλα τα κράτη της G 7.
6. Κάθε κράτος της G 7 θα μπορεί να αποφασίζει μεμονωμένα εάν και σε ποιο βαθμό τα απαιτούμενα στοιχεία μπορούν να **μειωθούν περαιτέρω**. Τα σύνολα στοιχείων που συμφωνήθηκαν αποτελούν τις ανώτατες προδιαγραφές. Επιτρέπεται να ζητούνται λιγότερα στοιχεία.
7. Προκειμένου να μειωθεί ο όγκος των κοινοποιήσεων που πρέπει να υποβάλλουν συνήθως οι επιχειρήσεις για τις διασαφήσεις, θα χρησιμοποιηθεί διεξοδικότερη **ανάλυση κινδύνων**, υποβοηθούμενη ηλεκτρονικά, συνοδευόμενη και/ή συμπληρούμενη από συντομευμένο, επιλεκτικό **λογιστικό έλεγχο**.
8. Όταν διεξάγονται έλεγχοι (είτε τυχαίοι είτε όταν υπάρχουν υπόνοιες παρανομίας) οι διοικήσεις δύνανται **ανά πάσα στιγμή** να ζητούν **περαιτέρω στοιχεία** (ακόμη και πέραν των ανώτατων προδιαγραφών σχετικά με τα σύνολα στοιχείων).
9. **Οι λοιπές τελωνειακές διαδικασίες**, συμπεριλαμβανομένων των απλουστευμένων, παραμένουν αμετάβλητες και **μπορούν να εξακολουθήσουν να εφαρμόζονται**.
