Subject: Submission of the Final Draft Implementing Technical Standards on Resolution Planning Reporting

Dear Mr Berrigan,

In accordance with Article 11(3) of Directive 2014/59/EU, the EBA is required to develop implementing technical standards specifying the procedures and standard forms and templates for the provision of information for the purposes of resolution plans.

The EBA updated the ITS in 2018 with a view to foster further harmonisation, since then, new data needs were identified by resolution authorities thereinafter based on the additional experience gained during this period, and separate data collections have been set up by the Single Resolution Board and by other resolution authorities. The current ITS comprehensive review aims on the one hand to further promote harmonisation, proportionality and simplification in resolution planning reporting by avoiding parallel data collections; and by eliminating data points either redundant or of limited value. On the other hand, it aims at improving the usability of the data collected by resolution authorities reflecting the latest developments in resolution planning, crisis preparedness and policies, and at delivering efficient practices.

It is my pleasure to submit to you today these draft implementing technical standards as endorsed by the EBA's Board of Supervisors. These standards were developed following the procedure described in Article 10 of Regulation (EU) No. 1093/2010 (EBA Regulation). As previously agreed, the draft implementing technical standards are attached in Legiswrite format.



In addition, the draft implementing technical standards will be published on the EBA's public website.

I look forward to the completion of the process and to the adoption of the standards.
