#### "LULUCF sink and 2030 target

The EU land use, land use change and forestry (LULUCF) sector both emits greenhouse gases and absorbs CO<sub>2</sub> in its soil and biomass. Restoring and growing our land carbon sink - the ability to absorb CO<sub>2</sub> by our natural environment such as trees - is crucial to our climate goals.

We need a growing sink in order for the EU to achieve climate neutrality by 2050. Reversing the current trend requires significant short-term action. The Commission Communication "Stepping up Europe's 2030 climate ambition - Investing in a climate-neutral future for the benefit of our people" estimates that it is needed and possible to reverse the current trend and increase the carbon sink to levels above 300 million tons CO<sub>2</sub>eq. by 2030.

The Commission will make proposals to revise the LULUCF Regulation, in line with this ambition."

### Statement by Luxembourg

"Le Luxembourg reste, de manière générale, très critique en ce qui concerne le financement des activités de recherche nucléaire par l'Union européenne. Le Luxembourg souhaiterait qu'une orientation des fonds européens, davantage axée sur les énergies renouvelables, soit exploitée à l'avenir. La proposition de 'Règlement du Conseil établissant le programme de recherche et de formation de la Communauté européenne de l'énergie atomique pour la période 2021-2025 complétant le programme-cadre pour la recherche et l'innovation "Horizon Europe"', ne préconisant pas une telle orientation, la position du Luxembourg reste inchangée. Malgré les réticences quant au contenu de cette décision, le Luxembourg est cependant en mesure de lever sa réserve générale et s'abstient par conséquent du vote."

"Luxembourg remains, in general, very critical towards the funding of nuclear research activities by the European Union. Luxembourg would like a reorientation of European funds, more focused on renewable energies, to be exploited in the future. Since the proposal of the 'Council Regulation establishing the European the Research and Training Programme of the European Atomic Energy Community for the period 2021 – 2025 complementing Horizon Europe – the Framework Programme for Research and Innovation' does not advocate such a reorientation, Luxembourg's position remains unchanged. Despite the reluctance as to the content of this Regulation, Luxembourg is however able to lift its general reservation and abstains therefore from the vote."

### Statement by Austria

"The Euratom Research and Training Programme 2021-2025 continues to put an emphasis on the improvement of nuclear safety, security and radiation protection. In addition, the programme aims at complementing the achievements of Horizon Europe's non-nuclear objectives, inter alia in the context of the energy transition. Austria understands this provision of the Euratom Research and Training Programme as a requirement for relevant nuclear research to duly justify its activities with regard to their contribution to a successful non-nuclear energy transition to which Horizon Europe contributes in the coming years.

Austria recalls its view that the energetic use of nuclear fission is neither a viable nor a cost efficient nor a sustainable option to combat the greenhouse effect. Austria does not support EU funding or any supportive framework on European level for nuclear power plants. As the compromise text achieved at political level still displays ambiguity in this regard, Austria, in line with its long-standing political consensus at national level, abstains."

Statement by Germany

"The Federal Republic of Germany welcomes the establishment of the Euratom Research Regulation (2021-2025). Germany agrees with the Regulation, but points out the following: Germany regrets that, despite long negotiations, it was not possible to agree on wording that makes it clear that not all Member States share the view that the results of Euratom's research constitute a potential contribution to developing a climate-neutral energy system (Recital 2) which is also considered safe and efficient, and that not all Member States consider this Regulation to make a contribution to the energy transition (Article 3(1)). Germany objects to such an interpretation, also in relation to other EU projects, and documents Germany's position in this statement, which can be referred to for any future interpretations. It is the sovereign right of each EU Member State to determine its own energy mix. However, we would have found it desirable for the statements made in the Regulation regarding the potential for nuclear power to contribute to mitigating climate change and undertaking the energy transition to better reflect the specific circumstances in the individual EU Member States. The EU Member States do not have a uniform, common understanding of this.

The termination of the use of nuclear energy for the commercial generation of electricity in Germany falls within the period of validity of the Euratom Research Regulation (2021-2025). In the field of nuclear fission, Euratom research will therefore focus on technical and scientific support for the operation of nuclear power plants in Germany until the end of 2022, the subsequent post-operational phase, the disposal of radioactive waste, radiation protection and the maintenance of competence in the longer term with a view to developments abroad. This future orientation of Germany's nuclear energy policy towards civil use must be taken into account in a balanced manner in relevant European decision-making processes, including in the context of potential project financing in accordance with Article 10 of the Regulation together with the corresponding recital (Recital 14)."

### Statement by the Commission

"Article 14(6) No-opinion clause

The Commission underlines that it is contrary to the letter and to the spirit of Regulation 182/2011 (OJ L 55 of 28.2.2011, p. 13) to invoke Article 5 § 4, subparagraph 2, point b) in a systematic manner. Recourse to this provision must respond to a specific need to depart from the rule of principle which is that the Commission may adopt a draft implementing act when no opinion is delivered. Given that it is an exception to the general rule established by Article 5 (4) recourse to subparagraph 2, point b), cannot be simply seen as a "discretionary power" of the legislator, but must be interpreted in a restrictive manner and thus must be justified. While the Commission notes the agreement reached by the European Parliament and the Council on the recourse to this provision, it regrets that such justification is not reflected in a recital."

### Statement by Hungary

"Hungary welcomes the outcome of the negotiations concerning the regulation on the European Institute for Innovation and Technology (EIT), which is an important step to ensure the effective functioning of the EIT.

The EIT's governance model is based on a strong, independent and high- level Governing Board. We strongly support that the EIT and its Governing Board shall be accountable to the Commission, Member States and European Parliament as well.

The draft regulation provides for granting supervisory role and *de facto* veto right to the European Commission which, according to Hungary, undermines the EIT's independence.

There is no reason for the proposed changes concerning the EIT's governing structure, Hungary therefore disagrees with it, because such restrictions seriously harm the EIT's independence.

Hungary underlines that all future measures should be in line with the principled-based provision on the EIT's operational independence, and shall carry out its activities independently of national authorities and external pressures."
