Proposal for a Regulation of the European Parliament and of the Council Subject:

establishing a European Training Foundation (recast)

- (8) On 17 July 1998 the Council adopted Regulation (EC) No 1572/98° amending Regulation (EEC) No 1360/90 with a view to including in the activities of the European Training Foundation the Mediterranean non-member countries and territories which are beneficiaries of the financial and technical measures to accompany the reform of their economy and social structures pursuant to Regulation (EC) No 1488/96.
- (9) On 5 December 2000 the Council adopted Regulation (EC) No 2666/2000¹⁰ on assistance for Albania, Bosnia and Herzegovina, Croatia, the Federal Republic of Yugoslavia and the Former Yugoslav Republic of Macedonia amending Regulation (EEC) No 1360/90 with a view to including in the activities of the European Training Foundation the Western Balkan States covered by the Regulation.

- In order to guarantee the full autonomy and independence of the Foundation, it should be granted an autonomous budget whose revenues come [...] **primarily** from a contribution from the Community. The auditing of accounts should be undertaken by the Court of Auditors.


