Statement by Belgium

"Belgium would like the Coreper minutes to take note of the following points with regard to
the partial mandate for negotiations with the European Parliament on the JTF:

- Belgium considers the JTF proposal an important instrument for financing the Green deal reforms.
- Belgium considers subsidiarity as a key element in the implementation of the JTF (and the JTM).
- The definition of the territories eligible to the JTF is part of the whole discussion in the framework of the Partnership with the Commission that will take place regarding the cohesion policy. Belgium welcomes the openness on the side of the European Commission to further discuss the territories to be identified under pillar I.

- Belgium supports the agreement reached within the Council on the substantial aspects of the JTF. Nevertheless, Belgium hopes that more information will become available on the articulation between the 3 pillars of the mechanism. In this regard Belgium would like to stress that also those sectors or regions that are particularly affected by climate transition but not specifically targeted under pillar I, can benefit from pillars II and III under the JTM.

With these elements in mind, Belgium can support the agreement."

Statement by Austria

"Austria's consent on the text of the Council Conclusions on Security and Defence is not to be understood as a prejudice on funding for the European Defence Fund, CEF/Military Mobility and the European Peace Facility in the context of the negotiations on the Multiannual Financial Framework and the European Recovery Instrument. In our view, "adequate funding" as mentioned in the Conclusions can also be understood as "lower funds".

"Ambitious" in the context of the European Defence fund as mentioned in the Conclusions is related to content and does not, as clarified by the Commission representative in PSC, relate to the financing granted to this Fund. Austria has reservations regarding those elements of the conclusions that could be interpreted as a call for an expanded budget for defence-related programmes. Against the backdrop of the negotiations on the next Multiannual Financial Framework and a European Recovery Instrument and in the presence of an unprecedented health related crisis, the scarce financial resources of the European budget need to be allocated and reprioritised in favour of those areas that most effectively help mitigate the present crisis and contribute most to the recovery."

This recital is substantially unchanged since it was originally included in the Maastricht Treaty in 1993. It is the TEU recital about CFSP, the ex-second pillar, in the same way as the 12th recital is the TEU recital about JHA, the ex-third pillar."

Statement by Poland

"Poland declares that the Communication from the Commission to the European Parliament, the Council, the European Economic and Social Committee and Committee of the Regions – A Union of Equality: Gender Equality Strategy 2020-2025 (Commission's Gender Equality Strategy 2020-2025; hereinafter referred to as "Strategy") mentioned in point 24 of the Conclusions on the impact of long-term care on work-life balance, should be interpreted with due regard to national competences and the specific circumstances in each Member State. At the same time Poland declares that equality between women and men is enshrined in the Treaties of the European Union as a fundamental right. Poland ensures equality between women and men within the framework of the Polish national legal system in accordance with internationally binding human rights instruments and within the framework of fundamental values and principles of the European Union. For these reasons, all references to "gender equality" within the Strategy will be interpreted by Poland as signifying "equality between women and men." In addition, where the Strategy refers to the concept of "sexual and reproductive health and rights", Poland will interpret it in accordance with the Programme of Action of the International Conference on Population and Development of 1994 and the Beijing Platform for Action of 1995, due to the fact that the term has no internationally recognized definition."

Statement of the Slovak Republic

"The Slovak Republic recognizes and promotes equality between men and women in accordance with the Constitution of the Slovak Republic and primary law of the European Union. In this context, the Slovak Republic interprets the concept of „gender“ in the text of the Council Conclusions as reference to sex and concept of „gender equality“ as reference to the equality between men and women."

Joint statement by Greece and Cyprus

"The Hellenic Republic and the Republic of Cyprus recognize the importance of and welcome the targeted amendments on the Capital Requirement Regulation in order to facilitate bank lending in response to the COVID-19 crisis.

However, the Hellenic Republic and the Republic of Cyprus regret the lack of ambition of the final text in two key points:

- a) EU does not make full use of the flexibility provided at international level with regard to the transitional arrangements for IFRS9, thus not ensuring level playing field at international level and within the EU, and
- b) the temporary re-introduction of "prudential filters" for sovereign exposures is too short, thus limiting the added value of this provision."

Statement by Finland

"In general, Finland welcomes the efforts to provide temporary relief for banks to facilitate lending as a matter of urgency during the global pandemic.

However, Finland is of the opinion that only temporary amendments and amendments directly targeted at the impacts of the pandemic should be made to the prudential framework in an accelerated procedure without an impact assessment and proper time for the national Parliaments to assess the amendments, as enshrined in Article 4 of Protocol No 1 on the role of national Parliaments in the European Union, annexed to the Treaties.

The amendments with support of the qualified majority in the Council and the European Parliament provide additional capital relief for banks. At the same time, they add to the risks stemming from banks' balance sheets. This is something Finland will consider when discussing further risk sharing in the context of the Banking Union. Only a healthy and stable banking sector can continue lending to the real economy throughout the downturn. Finland has particular concerns about the amendments that further strengthen the link between banks and sovereigns in Europe, when in fact a complete review of the regulatory treatment of sovereign exposures should be conducted to ensure that the risks to banks stemming from these exposures are properly reflected in prudential regulation."
