STATEMENT

Statement by the Commission

The Commission acknowledges the efforts of the European Parliament and of the Council to reach a rapid agreement but the Commission cannot support the amendment to increase the maximum percentage of the European Agricultural Fund for Rural Development that Member States can use for this measure from 1% to 2% of their envelopes. The additional impact on the level of payment appropriations in 2021 may negatively interfere with the on-going negotiations on the multiannual financial framework, and jeopardise other objectives of the Rural Development programmes.
