1. The General Secretariat of the Council has been informed of the resignation of Mr Marian TĂNASE, as alternate member of the Governing Board of the above Agency in the government representatives category (for Romania).
2. Under Article 8 of Regulation (EC) No 2062/94, as amended by Regulation (EC) No 1112/2005, members of the Governing Board are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EC) No 2062/94 of 18 July 1994 establishing a European Agency for Safety and Health at Work<sup>1</sup>, and in particular Article 8 thereof,

Whereas:

- (1) In its Decisions of 2 December 2013<sup>2</sup>, of 12 June 2014<sup>3,4</sup>, of 18 November 2014<sup>5</sup>, of 15 December 2014<sup>6</sup>, and of 16 March 2015<sup>7</sup> the Council appointed the members and alternate members of the Governing Board of the European Agency for Safety and Health at Work for the period ending on 7 November 2016.
- (2) A seat as alternate member in the government representatives category has fallen vacant as a result of the resignation of Mr Marian TĂNASE.
- (3) The government of Romania has nominated a candidate for the vacant seat,
