Proposal for a Regulation of the European Parliament and of the Council **(b)** amending Council Regulation (EC) No 1234/2007 as regards marketing standards 17677/10 AGRI 544 AGRIORG 67 CODEC 1491

The Committee took note of:

- the Commission's explanation on the coherence between the "place of farming" concept as set out in the Marketing standards proposal and the "place of provenance" concept as foreseen in the draft Regulation on Food Information to Consumers, noting that this latter Regulation is dealt with by Coreper;
- the delegations' views on the "place of farming" concept;
- the clarifications provided by the Commission on the "general marketing standard".

This, as well as the clarifications provided by the Commission, would facilitate the preparation of a Presidency paper on marketing standards to be discussed at the meeting of the Working Party on Horizontal Agricultural Questions on 11 and 12 April 2011.
