*Progress report**Confirmation of the common understanding***Statement of Denmark****Danish statement regarding the amnesty clause laid out in Article 5(1) of the transition regulation**

Denmark considers it important to ensure that the principles of sound financial management are followed as well as equal treatment of Member States and farmers.

Denmark is of the opinion that there are no objective reasons that may justify treating Member States applying Article 24 (6) of Regulation (EU) No 1307/2013 differently from Member States not applying this provision. The provision will undermine Member States' incentive to rectify incorrect implementation of the Common Agricultural Policy.
