on the European Union Integrated Border Management Assistance Mission in Libya  
(EUBAM Libya)**

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on European Union, and in particular Article 42(4) and Article 43(2) thereof,

Having regard to the proposal from the High Representative of the Union for Foreign Affairs and Security Policy,

Whereas:

- (1) On 22 May 2013, the Council adopted Decision 2013/233/CFSP<sup>1</sup> establishing the European Union Integrated Border Management Assistance Mission in Libya (EUBAM Libya).
- (2) On 26 June 2023, the Council adopted Decision (CFSP) 2023/1305<sup>2</sup> adapting and extending until 30 June 2025 the mandate of EUBAM Libya.
- (3) On 16 April 2025, in the context of the strategic review of EUBAM Libya, the Political and Security Committee agreed that the mandate of that mission should be extended by two years.
- (4) Decision 2013/233/CFSP should therefore be amended accordingly.
- (5) EUBAM Libya will be conducted in the context of a situation which may deteriorate and could impede the achievement of the objectives of the Union's external action as set out in Article 21 of the Treaty,

HAS ADOPTED THIS DECISION:

## *Article 1*

Decision 2013/233/CFSP is hereby amended as follows:

- (1) in Article 13(1), the following subparagraph is added:

‘The financial reference amount intended to cover the expenditure of EUBAM Libya from 1 July 2025 until 30 June 2027 shall be EUR 51 969 371,38.’;

- (2) Article 16 is replaced by the following:

*‘Article 16*

*Entry into force and duration*

This Decision shall enter into force on the date of its adoption.

It shall apply until 30 June 2027.’.

*Article 2*

This Decision shall enter into force on the date of its adoption.

It shall apply from 1 July 2025.
