On behalf of the President of the European Committee of the Regions (CoR), Vasco Alves Cordeiro, I would like to thank you for your referral request to the CoR, dated 10 March 2023, regarding the following dossier:

Proposal for a Regulation of the European Parliament and of the Council on specific rules relating to the entry into Northern Ireland from other parts of the United Kingdom of certain consignments of retail goods, plants for planting, seed potatoes, machinery and certain vehicles operated for agricultural or forestry purposes, as well as non-commercial movements of certain pet animals into Northern Ireland [COM (2023) 124 final - 2023/0062 (COD)].
