	- Adoption of the legislative act

1. On 14 December 2016 the Commission sent the above proposal¹, based on Article 33, Article 43(2), Article 53(1), Article 62, Article 64(2), Article 91, Article 100(2), Article 114, Article 153(2)(b), Article 168(4)(a), Article 168(4)(b), Article 172, Article 192(1), Article 207, Article 214(3), and Article 338(1) TFEU, to the Council.

- 2. The European Economic and Social Committee delivered its opinion on 1 June 2017².
- 3. The Committee of the Regions delivered its opinion on 1 December 2017³.
- 4. On 17 April 2019 the <u>European Parliament</u> adopted its position at first reading on the Commission proposal. The outcome of voting in the European Parliament reflects the compromise agreement reached between the institutions and should, therefore, be acceptable to the Council⁴.
- 5. The Permanent Representatives Committee is therefore asked to confirm its agreement as well as the Council statement set out in the <u>Addendum 2</u> to this note, which is to be entered in the summary record of the Permanent Representatives Committee's meeting.
- 6. The Permanent Representatives Committee is also asked to suggest that the Council:
 - approve the European Parliament's position, as set out in PE-CONS 65/19, as an
 "A" item at a forthcoming meeting;
 - decide that the statement in the <u>Addendum 1</u> to this note is be entered in the minutes of that meeting and published in the Official Journal of the European Union.

If the Council approves the European Parliament's position, the legislative act will be adopted.

After being signed by the President of the European Parliament and the President of the Council, the legislative act will be published in the Official Journal of the European Union.
