The <u>SCA</u> took note of the report of the Working Party on the outcome of the discussion on draft resolutions in step 7 intended to be submitted to the vote in the OIV General Assembly on 7 June 2013 (doc 8950/13).

The <u>SCA</u> noted that an agreement could not be reached on a draft Council Decision establishing a Union position, given that some delegations still had reserves on the principle of a Council Decision. The <u>SCA</u> further noted that the item would be put on the agenda of the Council meeting on 13-14 May 2013 as a "B" item.
