## ANNEX

1. In Article 5, the text “including untied official Development assistance” is added as follows:

*“b) The Arrangement shall apply to tied aid; the procedures set out in Chapter IV shall also apply to trade-related untied aid **including untied Official Development Assistance.**”*

2. In Article 40, letter d) is added as follows:

*“d) In addition to the information stipulated in Annex V that is provided for transactions that have been prior notified under Article 45, Participants shall provide, in the relevant ex-post reporting form, information on the contract awards for trade related untied aid and untied ODA credits. Where large prior-notified untied ODA credits or trade related untied aid transactions are comprised of more than one bidding contract, only those underlying contracts with a value of SDR two million and above would be subject to ex post transparency.”*

3. In Article 45, the text “and untied ODA credits” is added as follows:

*“a) A Participant shall give prior notification in accordance with Annex V if it intends to provide official support for:*

- (1) Trade-related untied aid **and untied ODA credits** with a value of SDR 2 million or more, and a concessionality level of less than 80%;*
- (2) Trade-related untied aid **and untied ODA credits** with a value of less than SDR 2 million and a grant element (as defined by the DAC) of less than 50%;*
- (3) Trade-related tied aid with a value of SDR 2 million or more and a concessionality level of less than 80%; or*
- (4) Trade-related tied aid with a value of less than SDR 2 million and a concessionality level of less than 50%, except for the cases set out in Articles 35 a) and 35 b).*
- (5) Tied aid in accordance with Article 35 d).”*

4. In Annex V, Section II, Paragraph I, three items are added as follows:

*“XX. type of procurement regime*

*XX. Bid Starting and closing date*

*XX. Information on the agency responsible for the procurement”*
